- The CTE Welding and LNA program will open up next week, with small groups in two shifts

- Budget Update: 1.5 million dollars has been cut from the budget to make the Council's appropriation that is going to the Public Hearing. Some items will be funded by grants. The largest portion comes from the major savings from the change in health insurance.
- The Superintendent gave an update from the work of the AVEC committee. A letter to the community went out recently from the Superintendents of SAU 3 and SAU 20 and the WMCC President discussing what is being done on the process of planning for next school year in the three institutions.
