### AN ORDINANCE AMENDING SECTION 110-138 OF THE CODE OF ORDINANCES OF THE CITY OF SPRINGDALE, ARKANSAS.

WHEREAS, Section 110-138 of the Code of Ordinances of the City of Springdale, Arkansas, contains the provisions and regulations pertaining to the assignment of, and amendment to, street names in the City of Springdale, Arkansas;

WHEREAS, Section 110-138 of the Code of Ordinances of the City of Springdale, Arkansas, should be amended to revise the procedures pertaining to the assignment of, and amendment to, street names in the City of Springdale, Arkansas; and

WHEREAS, a public hearing was held before the Springdale City Council on April 25, 2023, after notice was given of said hearing as currently required by Section 110-138 of the Code of Ordinances of the City of Springdale, Arkansas.

### NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL FOR THE CITY OF SPRINGDALE, ARKANSAS:

Section 110-138 of the Code of Ordinances of the City of Springdale, **Section 1:** Arkansas, is hereby amended to read as follows:

#### Sec. 110-138. Proposed amendments; hearing, notice.

On any proposed amendments to the regulations in this article or to the street address map, the City Council shall hold a public hearing, a notice of which shall be posted on the City's website and on the City's social media platforms at least 15 days prior to the date of the hearing. <u>In addition, notice shall be sent by</u> certified mail to all property owners whose street name would change due to the proposed amendment, advising of the date of the public hearing and the proposed street name change. Following the public hearing, the city council may adopt the amendment or amendments as recommended by the Information Technology Division (or other staff as appointed by the Mayor) or as determined by a majority vote of the city council.

All other provisions of Chapter 110 of the Code of Ordinances of the City of Springdale, Arkansas, not specifically amended by this ordinance shall remain in full force and effect.
