### Discussion Items:

- Talking Communities we need to renew if we want to continue using talking communities
- Collaboration with SEB and REC IX New SPED Directors' Academy coming up suggested topics included:
  - o K-3+ and ESY Relationship
  - o Early Childhood Transition Part C to B
  - Defining accommodations and modifications and the basics of writing goals and present levels of performance
  - o Budget 101: FTEs, MOE, IDEA, GO, Related Services
  - Autism Project 11 considerations for IEPs
  - Instead of New Directors invite all directors based on topics to be presented on the first day
  - o STARS 101
  - o Preparing for the PARC
  - O Agenda in advance to be able to pick and choose who to send Concerns were expressed about the agenda not being available until the last minute. Concerns were also expressed on the limitations on who can attend. It was felt that districts should be able to decide who should attend, and the training should be open to all. There was also a suggestion that strands be available to increase participation and differentiate the PD available. BIE schools are also interested in being able to participate.
- NM TEACH Group D Matt Montano asked Maria Jaramillo to establish a work group to determine how related services could be included in the evaluation process. There is a category for therapeutic specialist for direct service within the Danielson Framework. Strong has built on this work to include all related services. The work group provided recommendations, but no feedback has been provided yet. However, PED still contends that Group D will be included this year.
- Membership update − 61 CEC 7 FOC = 68 for last year − 61 CEC 8 FOC = 69 for this year − membership is steady and strong. IDEA funds can be used for membership.
