SUPERINTENDENT'S REPORT.

The current budget status was reviewed and indicates the district remains on track with expected expenditures and revenues and late state payments total \$184,610.60 at this point in the school year. A discussion was held on the current Covid-19 status; the district is totaling 96 lost workdays. A discussion was held on the additional funding the district will receive in regards to the pandemic. A discussion was held on the meeting with the Dream Team and their requests were to add intervention teachers, additional mental health support services, counseling, and outdoor learning spaces. The district will be holding an extended summer school program this year. The program will be broken down into four two-week sessions totaling eight weeks. The focus of learning will be math and reading across K-8th; 6th-8th will have additional materials in science and

social studies. Breakfast and lunch will be provided to students who attend the summer school program from 8:30 AM -11:30 AM. Kindergarten Boot Camp will be brought back this summer as well and is planned to be held two weeks before starting the 21-22 school year. A discussion was also held on the Jerseyville withdrawal from the Region III Co-Op. A resolution will need to be passed to approve their withdrawal date on June 30, 2023.
