# 8. New Business and Administrative Reports/Updates:

- a. Mrs. Fowler gave the following updates:
  - i. Julie Cook has been assigned out Teacher Powered School Liaison and she is virtually attending the August board meeting.
  - ii. There will be some shifting of staff for the upcoming school year. Melissa Comstock has previously been a classroom teacher, but she is going to be the special education teacher for the 23-24 school year. We will be applying for a permit from the State that will allow her be the special education teacher. We have also hired a full time paraprofessional and another full time employee that will be part paraprofessional part specials teacher. AnnaGrace Weaver has officially resigned as the 4<sup>th</sup> grade teacher. The rest of the staff will be assigned as follows: Mrs Medrano K/1, Miss Taylor 2/3, Ms. Coolman 4, Miss Tulloch, 5/6 and have we have posted for a 7/8 teacher.
  - iii. Hillsdale Prep is one of the schools in the county that has opted to be a leader in me school. All staff will be attending a training during professional development this year. All cost associated with this is being paid for by the ISD.
  - iv. The Board discussed Mrs. Fowler's self-evaluation. They thought it had good notes, was helpful and a fair self-assessment.

#### 9. GVSU Update:

a. Mr. Barker informed the Board that there is some staff transitioning at the Grand Valley Charter Office. He will keep them in the loop as new staff is hired. He also let them know the per-pupil funding is up 5% to \$9,608. Hillsdale Prep's charter contract with Grand Valley will be up for renewal in 2 years during the 24-25 school year.
