We are also trying to reduce the number of different teachers our 7th and 8th graders have by having their English and Social Studies teacher be the same person. This will, hopefully, make a smoother transition for our junior high students. At the elementary level, we are going to have a teacher provide a daily ESL intervention for our 5th and 6th graders and have our K-4 level 1 students have a daily intervention with an ESL teacher in hopes of increasing the quality of their ESL support.
