#### VII. RECOGNITION OF GUESTS AND PRESENTATIONS

Elementary Buildings: At various times throughout the school year, the three elementary buildings will combine forces to highlight various aspects of the District's Strategic Plan. This month, the elementary school principals focused on collaboration among schools and also community and families. This collaborative event was the Fourth-Grade Spirit Night Tailgate Party that took place at a seventh-grade football game at Serpentini Stadium. Each elementary school brought two student representatives to talk about their experience at the spirit night. Students present were: Albion - Brooklyn Weiss and Naomi Smelcer, Valley Vista - Dylan Toro and Taylor Heisler, and Royal View - Ali and Ben Harvanec.

Middle School: Sixth-grade student Malayah Tucker was recognized for being the only student on her team to participate in the VFW Patriot Pen Essay Contest and for going above and beyond in the classroom. She shared a portion of her essay with the Board.

High School: Jordan Evanko, Antonella Palmiero, and Natalie Rohrer were commended for their commitment as student athletic aides. These students are responsible for setting up the sideline for each game and all practices. This includes setting up the table and making sure all medical supplies are available. Before games, they also tape ankles, arches and wrists, and help players stretch and make sure they stay hydrated. In addition to this, they get good grades and play basketball, all while working with our athletic trainer six days a week after school.

# IX. COMMITTEE REPORTS

<u>Transportation</u> - Mrs. Arendt submitted the following report:

On Saturday, October 25 Bruce Abbott competed at the State Road-E-O, which was held in Grove City at South-Western City Schools Career Academy. We are excited to announce that Bruce tied for first place at the State Road-E-O and has advanced to compete and represent the State of Ohio at the International Bus Road-E-O held in the summer. Congratulations to Bruce for all of his hard work! We look forward to cheering him on at Internationals this summer!

Our T-1 student and mileage report has been submitted to the Ohio Department of Education. Our 50 route buses transport an average of 2,855 students per day and travel an average of 2,958 miles. Our vans transport 24 students daily and cover an average of 194 miles per day. Ridership is higher than last year, while miles traveled has decreased slightly.

During National School Bus Safety Week, October 21-October 25, our drivers completed their rear-door evacuation drills as required by the Ohio Department of Education. This is the first of three required bus evacuation drills. The second set of drills will be completed this week and they will be the front-door evacuation drills.

Lastly, our mechanics have been busy preparing the fleet for the cold weather by completing preventative maintenance services, checking and servicing the Webasto pre-heaters on the buses as well as the engine block heaters.

# <u>Cuyahoga Valley Career Center (CVCC)</u> - Mrs. Arendt submitted the following report:

On October 24, the all boards dinner commenced before the regular Board meeting. Those able to attend were treated to a long stroll to the Sports Medicine Exercise Science Room to view the newest program added just last year. During the dinner, guests heard about the wonderful program and community involvement in helping students interested in various health and fitness careers.

After dinner, the CVCC Board conducted a short business meeting. The next regular meeting is December 12, 2019.

# <u>Legislation Report</u> - Mrs. Arendt submitted the following report:

Last week, the House Finance Committee held a second hearing on House Bill (HB) 305, sponsored by Reps. Robert R. Cupp (R-Lima) and John Patterson (D-Jefferson), which creates a new school-funding formula.

The House Primary and Secondary Education Committee held a second hearing on HB 310, sponsored by Rep. Dave Greenspan (R-Westlake), which enacts the Ohio Anti-Bullying and Hazing Act with regard to school discipline and bullying and hazing policies at public schools and colleges.

The committee also heard sponsor testimony on:

• HB 322, sponsored by Reps. Don Jones (R-Freeport) and Don Manning (R-New Middletown), which revises the Ohio

Teacher Residency Program.

• HB 367, sponsored by Reps. Jessica E. Miranda (D-Winton Woods) and Susan Manchester (R-Waynesfield), which requires the state to recommend a job description for school counselors; requires public schools to consider those recommendations when preparing job descriptions and assigning duties for school counselors; and requires the designation of a school counselor liaison at the Ohio Department of Education.

The House Ways and Means Committee held a second hearing on HB 255, sponsored by Rep. James M. Hoops (R-Napoleon), which requires the state's tax expenditure report to include information on property tax exemptions and requires a periodic review of each property tax exemption.

The House Criminal Justice Committee held sponsor testimony on and accepted a substitute version of HB 83, sponsored by Rep. Richard D. Brown (D-Canal Winchester) and former Rep. Tim Schaffer (R-Lancaster), who was appointed to the Senate. The bill allows images captured by school bus cameras to be used as corroborating evidence for the offense of failing to stop for a school bus.

The House Health Committee passed HB 210, which requires the Ohio Department of Education-licensed preschool programs and other entities to screen and test prospective employees for tuberculosis and annually test certain employees for a five-year period.

The Senate Education Committee amended Senate Bill (SB) 102 during its fourth hearing, which requires public schools to conduct screenings of specified students and provide intervention services for those displaying risk factors for dyslexia, among other duties. The amendment now requires dyslexia screening assessments to be administered to students who do not attain a passing score on the third-grade English language arts assessment.

The committee held a third hearing on SB 121, which requires the State Board of Education to develop K-12 health education standards and revise the law regarding venereal disease education standards and curriculum.

The committee held a second hearing on HB 123, sponsored by Rep. Gayle Manning (R-North Ridgeville), which requires public schools to implement certain programs on and provide instruction in suicide awareness and prevention and violence prevention.

Finally, the committee held sponsor testimony on SB 200, sponsored by Sens. Peggy Lehner (R-Kettering) and Andrew O. Brenner (R-Powell), which requires professional development for screening and intervention for children with dyslexia, requires school districts to establish structured literacy certification procedures and requires districts to employ specified ratios of structured literacy-certified teachers.

#### Curriculum & Instruction and Pupil Services - Mrs. Reinkober submitted the following report:

**Curriculum:** Our first quarter professional development day was held on October 18. Middle and high school teachers continued to work on and fine-tune standards-aligned curriculum maps and common assessments. Science teachers at both levels heard a presentation on their final updated standards and gained access to the state's model curriculum. Additionally, at the high school, Mrs. Pozsgai, met with each department to discuss instructional technology needs in the new facility. Elementary school teachers reviewed work done previously on how to integrate Depth of Knowledge (DOK) into their activities and assessments to stretch their standards further, and finished work on their math curriculum maps.

Also this month the District Leadership Team and Elementary Leadership Team met to share out the progress being made at the building levels on their data-based goals. Members of the new District Literacy Committee have also been meeting and attending various best practice professional development sessions.

**Pupil Services:** During the month of October, the LRE committee has been meeting with various grade levels and departments across the District to share out information guarding the least restrictive environment and changes to the processes that the District is looking to implement in the next coming years. The goal of this committee is to provide all students with the greatest access to the general education curriculum taught by the content experts. These small group presentations have led to a variety of quality discussions on how best to serve and meet the needs of all students, especially students with disabilities.

During the first quarter professional development day, the entire special education department met to review our District data. Based on the data, discussions were held on how best to review the least restrictive environment for students when doing a review on an IEP and ways to meet those needs to ensure the highest quality level of instruction.

The ETR/IEP Committee shared out the professional development that will be provided throughout the year to each intervention specialist and speech language pathologist. The process to schedule professional development was reviewed with the teams. Professional development with individual teachers has already begun. The committee looks forward to this professional development impacting the achievement of students and the strengthening of teachers' skills.

# **<u>Professional Development</u>** - Mrs. Reinkober submitted the following report:

On October 15, I attended the OSBA Leadership Academy workshop at the ESC. The session presented by Jennifer Harden, Deputy Director of OSBA Legal Services was titled "Building a Workplace Free of Harassment." Topics covered included: What is (and is not) sexual harassment; steps to follow in responding to complaints; and building and sustaining a harassment-free workplace that respects all individuals. She also recommended that attendees review their anti-harassment policies to understand the processes in place for individuals to file complaints, the investigation procedures, and the individuals designated to receive complaints. Our District policy was last revised earlier this year.

# **<u>Buildings & Grounds</u>** - Mrs. Dolezal submitted the following report:

During the month of November, the maintenance department will be concentrating on getting all of the outside work finished up throughout the District before the cold weather and snow. Fall sports have come to an end for the most part, and now it's time to winterize the stadium and remove all the fence windscreens. Our sports fields have been winterized including aerifying, overseeding and sprinkler systems shut down.

All of the District maintenance trucks have been serviced by the transportation department. Soon, all the snowplows and salting equipment will be put on in preparation for the snow and ice in the near future.

Recently, we added additional lighting to our high school and middle school parking lots to make it safer for students and staff. This was due to the loss of most of our light poles where the new addition for the high school is being constructed.

We have been working on possibly utilizing a service ticket program for our maintenance department along with the technology department. Both departments have met with multiple providers, and over the next couple weeks we will test a couple of demo's to see if they may suit our needs in the District. This will allow us to be more efficient in many different aspects of our District.

In conclusion, the newest member of our maintenance department, Raphael Pikach, has recently started work. Raphael has experience in working in a school district. He brings many benefits to our department and we look forward to working with him.

#### Financial Advisory & Audit Committee - Mrs. Dolezal submitted the following report:

Treasurer Biagio Sidoti presented a review of the District financial report as of September 30, 2019.

The committee was given an update of the facilities construction projects at the middle school, high school and elementary school site.

Next, the committee was presented with information regarding different scenarios for the refunding of a certificate of participation.

Finally, the committee reviewed the November required submission of the District five-year forecast.

# <u>Professional Development</u> - Mrs. Dolezal submitted the following report:

Mrs. Dolezal attended the OSBA Leadership Academy professional development session entitled, "Building a Workplace Free of Harassment," presented by Deputy Director of OSBA Legal Services Jennifer Hardin.

Jennifer presented the definitions, legalities, and protocol a district must follow regarding sexual harassment claims and hostile work environment claims.

Districts must work to prevent occurrences and protect the employees. Districts must also have sexual harassment protocol. Every district must have a trained Title IX coordinator.

Improper behavior categories would be Illegal, Impermissible, Inappropriate, Improper, Discriminating, or Disruptive Behavior.

If a claim is made, it is important to remain objective; first investigate, then respond.

Board members should show respect, compassion, objectivity, follow policy, documentation, and confidentiality.

Finally, a harassment-free environment encompasses Diversity, Inclusion, and Equity.

# North Royalton Recreation Board Report - Dr. Kelly submitted the following report:

The North Royalton Recreation Board met on October 29. Soccer reported a successful fall season with, for the first time in memory, no rainouts. They will be holding their elections for officers on November 12. Baseball will open registration for travel on November 1 and has switched software programs. They will also be coordinating this year with the high school baseball coaches for some combined clinics and coordinated activities to improve communication and enhance instruction for recreation and travel players. The YMCA is two weeks into junior Cavs basketball and has hired Jeff Jacko as the Director of the North Royalton YMCA. Jeff is a member at the North Royalton facility and has served as a director at other YMCA facilities in the past.

Basketball reported that they have formed the teams for the coming season. They have chosen to augment gym time by purchasing some hours at a private facility. Boys games will start on November 24 and the girls shortly thereafter. The boys will participate in a youth basketball night at the high school on December 28 and they are working to set up something similar for the girls. The Community Garden is in the process of completing a 2500 square foot expansion of the garden. They thanked the 15 volunteer high school students who moved several yards of topsoil in very short order for them. Their output was down this past year due to weather, but they look forward to expanded output next growing season.

The recreation department reported that they have completed aeration and over-seeding at York and Heasley fields. Weather permitting, they are also working on drainage projects at York 2 and York 4 fields. They are getting estimates from outside contractors on the costs of converting the lighting at York Road to LEDs and will then apply for a grant to NOPEC for the project.

The next meeting of the recreation board is November 26, 2019.

# **<u>Policy Committee Report</u>** - Dr. Kelly submitted the following report:

The Policy Committee will meet on Tuesday, November 19, 2019, at 4 p.m. to review and finalize the remaining policy updates included in NEOLA Volume 38 #1. This round of updates contains policies which address a number of areas including: Late Arrival and Early Dismissal, Student Mental Health and Suicide Prevention, Disposition of Real Property, Small Unmanned Aircraft Systems, School Safety, Student Abuse and Neglect, and Food Service. The committee will make recommendations for the Board to review and approve in December.

# <u>Community Facilities Advisory Committee</u> - Dr. Kelly submitted the following report:

Members of the Community Facilities Advisory Committee and the Financial Advisory and Audit Committee were given the opportunity to tour the construction sites of the North Royalton Elementary School and the North Royalton High School expansion on October 23.

The tour was led by representatives of Hammond Construction with members of the design team from ThenDesign Architects also present. The committee members were able to see firsthand the significant progress that has been made on both sites. The goal for the elementary building is to have the common area under roof and enclosed so that over the winter work can continue on mechanicals and building infrastructure.

At the high school site, much of the steelwork is done. Also, a great deal of concrete has been poured. The goal at the high school site is to have the building superstructure completed and the building enclosed by approximately the end of November. This would then allow the inside work on the new addition to continue throughout the winter months. The members of the committees were very impressed with the dramatic changes to the connecting spaces at the high school, and the significant progress to date at both sites.

As has been noted in other comments, both projects remain on time and on budget.

#### **<u>Professional Development</u>** - Dr. Kelly submitted the following report:

I attended the OSBA Leadership Academy professional development session entitled, "Building a Workplace Free of Harassment," presented by Deputy Director of OSBA Legal Services Jennifer Hardin. She began with a review of the law illustrating the legal concepts by presenting actual examples from case law.

She also covered some of the important policies that need to be in place not only to comply with the law, but to provide a work and educational environment which makes it clear that harassment in any form will not be tolerated. It is also important that the reporting mechanisms be consistent and easily available so that any issues when raised can be investigated and acted upon swiftly. She gave us homework to check for benchmarks in our own policy. It was gratifying to see that our own policy was in line with all the important aspects of this very important area where the underlying philosophy must be one of respect for all employees and, of course students.

#### X. REPORTS AND RECOMMENDATIONS OF THE TREASURER

1. RESOLUTION 2019-325: A RESOLUTION APPROVING AND AUTHORIZING A SUPPLEMENTAL LEASE-PURCHASE AGREEMENT, ESCROW AGREEMENT AND RELATED DOCUMENTS PROVIDING FOR REFINANCING THE COSTS OF THE CONSTRUCTION, FURNISHING AND EQUIPPING, AND THE LEASE AND EVENTUAL ACQUISITION, OF IMPROVEMENTS TO THE SCHOOL DISTRICT'S BUILDINGS AND BUILDING SITES, INCLUDING IMPROVEMENTS TO THE SCHOOL DISTRICT'S HIGH SCHOOL STADIUM AND BUILDING SITE AND OTHER IMPROVEMENTS FOR SCHOOL DISTRICT PURPOSES, AND AUTHORIZING AND APPROVING OTHER RELATED MATTERS.

WHEREAS, Section 3313.375 of the Revised Code provides that the board of education of a school district may enter into a lease-purchase agreement providing for the construction, enlarging or other improvement, furnishing and equipping, and lease and eventual acquisition of facilities or improvements to facilities any for school district purpose, and, in conjunction therewith, may grant a lease for land under the board's control for a period not more than five years longer than the term of the lease-purchase agreement; and

WHEREAS, Section 3313.375 further provides that the obligations of the board of education under such a lease-purchase agreement shall not be construed as net indebtedness of that school district pursuant to Section 133.06 of the Revised Code; and

WHEREAS, pursuant to Resolution No. 2011-27, adopted by this Board on February 14, 2011, this Board entered into the Ground Lease and the Master Lease and approved the Master Assignment and Master Trust Agreement providing for the construction, furnishing and equipping, and lease and eventual acquisition, improvements to the School District's buildings and building sites, including improvements to the School District's high school stadium and building site and other improvements for School District purposes; and

WHEREAS, the Trustee issued and sold the Series 2011 Certificates pursuant to the Master Trust Agreement to finance such improvements; and

WHEREAS, this Board has determined to enter into the Supplemental Lease, and to approve the Trustee's entering into the Supplemental Assignment and the Supplemental Trust Agreement and issuing and selling the Series 2019 Certificates as additional certificates pursuant to the Trust Agreement to refund all or a portion of the outstanding Series 2011 Certificates, thereby achieving cost savings with respect to the annual costs to this Board of leasing and eventually acquiring the Project Facilities, all in accordance with the Trust Agreement and the laws of the State of Ohio, including, but not limited to, Section 3313.375 of the Revised Code; and

NOW, THEREFORE, BE IT RESOLVED by the Board of Education of the North Royalton City School District, County of Cuyahoga, State of Ohio, that:

**Section 1. Definitions**. In addition to the words and terms defined in the recitals to this Resolution and in the Lease, the following words and terms shall have the following meanings unless the context or use clearly indicates another or different meaning or intent:

"Assignment" means the Master Assignment, as supplemented from time to time in accordance with its terms, including by the Supplemental Assignment, assigning to the Trustee the Lessor's interests in the Ground Lease and the Lease.

"Base Rent" means the payments specified as Base Rent in the Lease.

"Board" means the Board of Education of the School District.

"Certificate Payments" means, for any period or payable at any time, the principal of and interest and any premium on the Certificates for that period or payable at that time (whether on a scheduled payment date or pursuant to or upon redemption or otherwise), as the case may be.

- "Certificates" means Certificates of Participation in the payments of Base Rent to be made by the Board under the Lease to be issued as one or more series under the Trust Agreement for the purpose of paying Project Costs, and which will constitute "fractionalized interests in public obligations", as defined in Section 133.01 of the Revised Code.
- "Closing Date" means, as to the Series 2019 Certificates, the date of physical delivery of, and payment of the purchase price for, the Series 2019 Certificates.
- "Code" means the Internal Revenue Code of 1986, as amended, the Treasury Regulations (whether temporary or final) under that Code or the statutory predecessor of that Code, and any amendments of or successor provisions to the foregoing and any official rulings, announcements, notices, procedures and judicial determinations regarding any of the foregoing, all as and to the extent applicable. Unless otherwise indicated, reference to a section of the Code includes any applicable successor section or provision and applicable Treasury Regulations, rulings, announcements, notices, procedures and determinations pertinent to that section.
- "Corporation" means Ohio School Building Leasing Corporation, an Ohio nonprofit corporation.
- "Escrow Agreement" means the Escrow Agreement, dated as of the Closing Date, between the Board and the Escrow Trustee, and relating to the refunding of the Refunded Certificates.
- "Escrow Fund" means the Escrow Fund created under the Escrow Agreement.
- "Escrow Trustee" means the Trustee, as Escrow Trustee under the Escrow Agreement.
- "Fiscal Officer" means the Treasurer of the Board.
- "Ground Lease" means the Ground Lease between the Board, as lessor, and the Lessor, as lessee, conveying a leasehold interest in the Project Site.
- "Lease" means the Master Lease, as supplemented from time to time in accordance with its terms, including by the Supplemental Lease, conveying a leasehold interest in the Leased Property, and under which the Board shall lease the Leased Property for consecutive annual renewable terms that are subject to renewal upon appropriations being made by this Board of funds sufficient to pay the Lease Payments due during each such term.
- "Leased Property" means collectively the Project Site and the Project Facilities.
- "Lessor" means the Corporation and its successors and assigns as lessee under the Ground Lease and as lessor under the Lease, including the Trustee.
- "Master Assignment" means the Assignment of Leases, dated as of April 1, 2011, between the Corporation and the Trustee
- "Master Lease" means the Lease-Purchase Agreement, dated as of April 1, 2011, between the Lessor, as lessor, and the Board, as lessee.
- "Master Trust Agreement" means the Trust Agreement, dated as of April 1, 2011, between the Corporation and the Trustee
- "Original Purchaser" means Key Government Finance, Inc., or such other purchaser or purchasers as are specified as the first registered owner of the Series 2019 Certificates in the Term Sheet, provided that at the request of the first registered owner an appropriate designation other than Purchaser may be used.
- "Other Facilities" means improvements to School District buildings and building sites not included in the Leased Property.
- "Placement Agent" means Stifel, Nicolaus & Company, Incorporated.
- "Placement Agent Agreement" means the Placement Agent Engagement Agreement authorized in Section 10, between the Placement Agent and the Board.
- "President" means the President of the Board.
- "Project Costs" means the costs of the Project Facilities and Other Facilities, including the interest component of Base Rent accruing during construction and costs of issuing the Certificates.
- "Project Facilities" means the improvements to the School District's high school stadium and building site and related improvements as described in the Lease, together with any additions, modifications and substitutions thereto as permitted under the Lease.
- "Project Site" means the Project Site as described in the Lease, being generally the real property comprising the site of the School District's high school stadium.
- "Redemption Date" means the date as specified in the Escrow Agreement, provided, however, that such date shall be no later than 90 days after the Closing Date.
- "Refunded Certificates" means all or a portion of the outstanding Series 2011 Certificates.
- "Rule" means Rule 15c2-12 prescribed by the SEC pursuant to the Securities Exchange Act of 1934, as it may be amended and/or supplemented from time to time.
- "School District" means the North Royalton City School District, Ohio.
- "SEC" means the Securities and Exchange Commission.
- "Series 2011 Certificates" means the \$3,070,000 Certificates of Participation, Series 2011, dated April 7, 2011.
- "Series 2019 Base Rent" means the payments specified as Series 2019 Base Rent in the Supplemental Lease.

- "Series 2019 Certificates" means the Additional Certificates authorized by this Resolution to be issued under the Indenture for the purpose of refinancing Project Costs.
- "Superintendent" means the Superintendent of the School District.
- "Supplemental Assignment" means the 2019 Supplemental Assignment authorized in Section 2, supplementing the Master Assignment.
- "Supplemental Trust Agreement" means the 2019 Supplemental Trust Agreement authorized in Section 2, supplementing the Master Trust Agreement.
- "Supplemental Lease" means the 2019 Supplemental Lease Agreement authorized in Section 2, amending and supplementing the Master Lease.
- "Tax-Exempt Obligations" means obligations to which Section 103 of the Code applies, the interest on which is excluded from gross income for federal income tax purposes.
- "Tax Status" means the status of Certificates as Tax-Exempt Obligations.
- "Term Sheet" means the Term Sheet authorized in Section 4.
- "Trust Agreement" means the Master Trust Agreement, as supplemented from time to time in accordance with its terms, including by the Supplemental Trust Agreement, pursuant to which the Lessor has and is authorized to further direct the Trustee to and the Trustee has and may further issue and sell the Certificates, and proceeds of the sale of the Certificates to be made available to finance or refinance Project Costs.
- "Trustee" means the bank or trust company at the time serving as Trustee under the Trust Agreement, initially The Huntington National Bank.
- Ground Lease, Lease and Trust Agreement. It is necessary, proper and in the best interest of the School District to authorize, and this Board does hereby authorize, the signing, delivery and sale of the Series 2019 Certificates as Additional Certificates under the Trust Agreement on terms consistent with this Resolution to provide funds to refund the Refunded Certificates, including payment of expenses relating to the issuance of the Series 2019 Certificates and the refunding of the Refunded Certificates. The Certificates shall be designated "Refunding Certificates of Participation, Series 2019, Evidencing the Proportionate Interests of the Owners Thereof in Base Rent to Be Paid by the Board of Education of the North Royalton City School District, Ohio." The President and the Fiscal Officer is each authorized to sign and deliver the Supplemental Lease and to signify approval of the Supplemental Assignment and the Supplemental Trust Agreement in substantially the forms as are now on file with this Board. Each of the Supplemental Lease, the Supplemental Assignment and the Supplemental Trust Agreement is approved in substantially the form as is now on file with this Board, together with any changes or amendments that are not inconsistent with this Resolution and are not substantially adverse to the School District that are approved by the officer or officers signing that document on behalf of the Board, all of which shall be conclusively evidenced by the signing of the Supplemental Lease or amendments thereto and the signifying of approval of the Supplemental Assignment and the Supplemental Trust Agreement or amendments thereto by that officer or those officers. The Board's obligation to pay Base Rent during each term of the Lease shall constitute a "public obligation" and the Series 2019 Certificates shall constitute "fractionalized interests in public obligations", each as defined in Section 133.01 of the Revised Code. Any provision herein notwithstanding, the entire principal amount of the Series 2019 Certificates may be represented by a single certificate with multiple payments of principal listed on a principal payment schedule attached thereto.
- **Section 3. Leased Property**. This Board hereby confirms its determination that the Leased Property and its use are essential to the School District including but not limited to its proper, efficient and economic operation and the welfare of its students.

# Section 4. <u>Determination of Lease Terms and Sale of the Series 2019 Certificates.</u>

(a) <u>Lease Terms</u>. The Fiscal Officer is hereby authorized to determine (which determination shall be confirmed by the Fiscal Officer by the signing of the Term Sheet), having due regard for the best interest of and financial advantages to the School District: (i) the schedule of Certificate Payments and the Base Rent payable under the Lease with respect to the Series 2019 Certificates, provided, that: (A) neither the aggregate principal amount of the Certificates nor the aggregate principal components of Base Rent shall exceed \$[2,700,000], (B) the final Certificate Payment shall not be later than 30 years after the commencement date of the Master Lease, and (C) the aggregate true interest cost of the Certificates shall not exceed 6.50% per year, and (ii) the redemption terms, if any, for the Certificates and the corresponding prepayment provisions under the Lease.

The School District acknowledges that the aggregate principal component of the Series 2019 Base Rent shall be equal to the aggregate principal amount of the Series 2019 Certificates (net of any original issue discount) and shall be that amount that, together with other funds to be made available for that purpose, shall be sufficient to pay the cost of refunding the Refunded Certificates, including without limitation the cost of capitalized interest and providing any reserves that the Fiscal Officer determines are necessary and appropriate for the Series 2019 Certificates to be issued on the terms most favorable to the School District as the payor on the public obligations in which the Series 2019 Certificates constitute fractionalized interests, and the costs of issuance of the Series 2019 Certificates to be paid from the proceeds of the Series 2019 Certificates, which the Fiscal Officer determines are necessary and reasonable in light of the character of the Certificates. The School District further acknowledges that the Certificate Payments shall include interest payments that shall be based upon the interest components of the Series 2019 Base Rent payable under the Lease. The Base Rent to be payable during the aggregate lease term of the Lease shall be an amount sufficient to cover the Certificate Payments, and such Base Rent shall be specified or determined in an exhibit to the Lease; provided, however, that the School District's obligation to pay Base Rent is subject to appropriation and certification as provided in the Lease and nothing in the Lease, the Series 2019 Certificates or the Trust Agreement shall constitute a debt of the Board or a pledge by the Board, or an obligation of the Board, of any taxes or other money to the payments due thereunder.

All determinations required by this subsection (a0 shall be confirmed by the signing of the Term Sheet by the Fiscal Officer or the President.

- (b) <u>Term Sheet</u>. The Fiscal Officer or, in the absence of the Fiscal Officer, the President, is authorized to sign and deliver, in the name and on behalf of the School District, the Term Sheet providing for the sale of the Series 2019 Certificates, provided that the purchase price for the Series 2019 Certificates shall not be less than 95% of the aggregate principal amount thereof and the terms stated in the Term Sheet shall not be inconsistent with this Resolution, all of which shall be conclusively evidenced by the signing of the Term Sheet by that officer.
- (c) <u>Use of Proceeds of the Series 2019 Certificates</u>. The proceeds received by the School District from the sale of the Series 2019 Certificates shall be paid into the Escrow Fund and, if applicable, the Certificate Fund or used to pay costs of issuance of the Series 2019 Certificates, and those proceeds shall be invested and applied in accordance with the Escrow Agreement and Trust Agreement. The expenditure of the amounts necessary to pay the financing costs (as defined in Section 133.01 of the Revised Code) in connection with the Series 2019 Certificates is authorized and approved, and the Fiscal Officer is authorized to provide for the payment of any such amounts and costs from the proceeds of the Series 2019 Certificates to the extent available and otherwise from any other funds lawfully available that are appropriated or shall be appropriated for that purpose.

#### Section 5. <u>Refunding of Refunded Certificates</u>.

(a) This Board determines that it is necessary and in the best interest and financial advantage of the School District to provide for the refunding of the Refunded Certificates by the payment of the principal of and interest on the Refunded Certificates pursuant to the Escrow Agreement and as provided in this Resolution, and to redeem the Refunded Certificates on the Redemption Date, with notice of call for redemption being given consistent with the Trust Agreement.

As provided in the Escrow Agreement, timely after the delivery of and payment for the Series 2019 Certificates and the credit to the Escrow Fund created under the Escrow Agreement as provided in this Resolution, the Refunded Certificates shall be called for prior redemption. The Fiscal Officer is authorized and directed to give to the Trustee, on or promptly after the Closing Date, written notice of the call for redemption, and the Refunded Certificates shall be redeemed in accordance with the provisions of this Resolution, the Trust Agreement and the Escrow Agreement. The School District covenants for the benefit of the holders of the Refunded Certificates and of the Series 2019 Certificates, that it will at no time on or after the Closing Date take actions to modify or rescind that call for prior redemption, and that it will take, and will cause the Trustee to take, all steps required by the terms of the Refunded Certificates to make and perfect that call for prior redemption.

- (b) The Fiscal Officer shall sign and deliver, in the name and on behalf of the School District, the Escrow Agreement between the School District and the Escrow Trustee, in substantially the form as is now on file with the Fiscal Officer. The Escrow Agreement is approved, together with any changes or amendments that are not inconsistent with this Resolution and not substantially adverse to the School District and that are approved by the Fiscal Officer on behalf of the School District, all of which shall be conclusively evidenced by the signing of the Escrow Agreement or amendments thereto. The Fiscal Officer shall provide for the payment of the services rendered and for reimbursement of expenses incurred pursuant to the Escrow Agreement (including, if required, the fees and expenses of a mathematical verification agent to be appointed by the Fiscal Officer) from the proceeds of the Series 2019 Certificates to the extent available and then from other money lawfully available and appropriated or to be appropriated for that purpose.
- (c) There is created under the Escrow Agreement a trust fund designated the "North Royalton City School District Series 2011 Certificates Escrow Fund" which shall be held and maintained by the Escrow Trustee in trust for the registered owners of the Refunded Certificates and is pledged for the payment of principal of and interest on the Refunded Certificates, all in accordance with the provisions of the Escrow Agreement and the Trust Agreement. The Fiscal Officer is hereby authorized and directed to pay or cause to be paid to the Escrow Trustee for deposit in the Escrow Fund (i) any available funds on deposit in the Certificate Fund for the payment of debt charges on the Refunded Certificates held under the Trust Agreement and required to be used for such purpose and (ii) proceeds from the sale of the Series 2019 Certificates, except any accrued interest and any proceeds to be used for the payment of any expenses properly allocable to the refunding of the Refunded Certificates or the issuance of the Series 2019 Certificates, in the amount required, together with the funds referred to in clause (i), if any, to provide for the defeasance of the Refunded Certificates. Those funds are appropriated and shall be applied to pay principal of and interest and redemption premium, if any, on the Refunded Certificates, as provided in the Escrow Agreement.
- If U.S. Treasury Securities State and Local Government Series are to be purchased for the Escrow Fund, the Escrow Trustee is hereby specifically authorized to file, on behalf of the School District, subscriptions for the purchase and issuance of those U.S. Treasury Securities State and Local Government Series. If, in the judgment of the Fiscal Officer, an open-market purchase of obligations described in (b) in the preceding paragraph for the Escrow Fund is in the best interest of and financially advantageous to the School District, the Fiscal Officer, or any other officer of the School District, on behalf of the School District and in their official capacity, may purchase and deliver such obligations, engage the services of a municipal advisor, bidding agent or similar entity for the purpose of facilitating the bidding, purchase and delivery of such obligations for, and any related structuring of, the Escrow Fund, execute such instruments as are deemed necessary to engage such services for such purpose, and provide further for the payment of the cost of obtaining such services from the proceeds of the Series 2019 Certificates to the extent available and otherwise from any other funds lawfully available and that are appropriated or shall be appropriated for that purpose.
- Section 6. Other Instruments. The President, the Superintendent and the Fiscal Officer are each hereby authorized to take any and all other actions and to sign and deliver any and all other instruments, agreements, certificates and documents as may in their judgment be necessary, desirable, advisable or appropriate in connection with the signing and delivery of the Supplemental Lease, the signing and delivery of the Series 2019 Certificates by the Trustee and the purchase of the Series 2019 Certificates by the Original Purchaser in order to give effect to the transactions contemplated to be performed on the part of the School District under the Supplemental Lease.
- Section 7. Tax Covenants. The Fiscal Officer or any other officer having responsibility for signing the Supplemental Lease, is, alone or in conjunction with any of the foregoing or with any other officer or employee of the School District, authorized to cooperate with the Original Purchaser and the Trustee by making, on behalf of the School District, such covenants and representations in the Supplemental Lease as are appropriate and necessary so that (a) the Lease and the Series 2019 Certificates will not (i) constitute private activity bonds or arbitrage bonds under Sections 141 or 148 of the Internal Revenue Code of 1986, as amended (the Code) or (ii) be treated other than as obligations to

which Section 103 of the Code applies, (b) the interest on the Series 2019 Certificates will not be treated as an item of tax preference for purposes of the federal alternative minimum tax, (c) the School District will take or cause to be taken such actions that may be required of it for the interest on the Series 2019 Certificates to be and to remain excluded from gross income for federal income tax purposes, (d) the School District will not take or authorize to be taken any actions that would adversely affect that exclusion, and (e) the School District, or persons acting for it, will, among other acts of compliance, (i) apply or cause the application of the proceeds of the Series 2019 Certificates to the governmental purpose of the borrowing, (ii) restrict the yield on investment property acquired with those proceeds, (iii) make timely and adequate payments to the federal government, (iv) maintain books and records and make calculations and reports, and (v) refrain from certain uses of those proceeds, and, as applicable, of property financed with such proceeds, all in such manner and to the extent necessary to assure such exclusion of that interest under the Code. The Fiscal Officer or any other officer of the School District having responsibility for signing of the Supplemental Lease is hereby authorized (a) to make or effect any election, selection, designation, choice, consent, approval, or waiver on behalf of the School District with respect to the Series 2019 Certificates as the School District is permitted to or required to make or give under the federal income tax laws, including, without limitation thereto, any of the elections provided for or available under Section 148 of the Code, for the purpose of assuring, enhancing or protecting favorable tax treatment or Tax Status of the Series 2019 Certificates or the interest components thereof or assisting compliance with requirements for that purpose, reducing the burden or expense of such compliance, reducing the rebate amount or payments or penalties, or making payments of special amounts in lieu of making computations to determine, or paying, excess earnings as rebate, or obviating those amounts or payments, as determined by that officer, which action shall be in writing and signed by the officer, (b) to take any and all other actions, make or obtain calculations, make payments, and make or give reports, covenants and certifications of and on behalf of the School District, as may be appropriate to assure the intended Tax Status of the Series 2019 Certificates, and (c) to give one or more appropriate certificates of the School District, for inclusion in the transcript for the Series 2019 Certificates, setting forth the reasonable expectations of the School District regarding the amount and use of all the proceeds from the sale of the Series 2019 Certificates, the facts, circumstances and estimates on which they are based, and other facts and circumstances relevant to the tax treatment of the interest on the Series 2019 Certificates and the Tax Status of the Series 2019 Certificates. The Fiscal Officer is specifically authorized to designate the School District's obligation to pay 2019 Base Rent as a "qualified tax-exempt obligation" if such designation is applicable and desirable, and to make any related necessary representations and

- **Section 8.** Severability. Each section of this Resolution and each part of each section hereof is hereby declared to be independent, and the finding or holding of any section or part of any section hereof to be invalid or void shall not be deemed or held to affect the validity of any other section or part of any section of this Resolution.
- **Section 9.** Retention of Bond Counsel. The legal services of Squire Patton Boggs (US) LLP, as bond counsel, are hereby retained. The legal services shall be in the nature of legal advice and recommendations as to the documents and proceedings in connection with the issuance and sale of the Series 2019 Certificates, and the rendering of the necessary legal opinions upon the delivery of the Series 2019 Certificates. In rendering those legal services, as an independent contractor and in an attorney-client relationship, that firm shall not exercise any administrative discretion on behalf of the School District in the formulation of public policy, expenditure of public funds, enforcement of laws, rules and regulations of the State, the School District or any other political subdivision, or the execution of public trusts. That firm shall be paid just and reasonable compensation for those legal services and shall be reimbursed for the actual out-of-pocket expenses it incurs in rendering those legal services whether or not the Series 2019 Certificates are issued. The Fiscal Officer is authorized and directed to make appropriate certification as to the availability of funds for those fees and any reimbursement and to issue an appropriate order for their timely payment as written statements are submitted by that firm.
- **Retention of Placement Agent**. The services of Stifel, Nicolaus & Company, Incorporated, as placement agent, are hereby retained. Those services shall be in the nature of soliciting proposals from potential purchasers of the Series 2019 Certificates and negotiating the terms of the purchase of the Series 2019 Certificates by the Original Purchaser. In rendering those services, as an independent contractor, that firm shall not exercise any administrative discretion on behalf of the School District in the formulation of public policy, expenditure of public funds, enforcement of laws, rules and regulations of the State, the School District or any other political subdivision, or the execution of public trusts. That firm shall be paid just and reasonable compensation for those services and shall be reimbursed for the actual out-of-pocket expenses it incurs in rendering those services. The Fiscal Officer is authorized and directed, to the extent they are not paid by the Original Purchaser, to make appropriate certification as to the availability of funds for those fees and any reimbursement and to issue an appropriate order for their timely payment as written statements are submitted by that firm. The Fiscal Officer shall sign and deliver, in the name and on behalf of the School District, the Placement Agent Agreement between the School District and the Placement Agent, in substantially the form as is now on file with the Fiscal Officer. The Placement Agent Agreement is approved, together with any changes or amendments that are not inconsistent with this Resolution and not substantially adverse to the School District and that are approved by the Fiscal Officer on behalf of the School District, all of which shall be conclusively evidenced by the signing of the Placement Agent Agreement or amendments thereto.
- **Section 11. Prior Acts Ratified and Confirmed**. Any actions previously taken by School District officials or agents of this Board in furtherance of the matters set forth in this Resolution are hereby approved, ratified and confirmed.
- **Section 12.** Compliance with Open Meeting Law. This Board finds and determines that all formal actions of this Board and of any of its committees concerning and relating to the adoption of this Resolution were taken, and that all deliberations of this Board and of any of its committees that resulted in those formal actions were held, in meetings open to the public in compliance with the law.
- **Section 13.** Captions and Headings. The captions and headings in this Resolution are solely for convenience of reference and in no way define, limit or describe the scope or intent of any Sections, subsections, paragraphs, subparagraphs or clauses hereof.
- Section 14. <u>Effective Date</u>. This Resolution shall be in full force and effect immediately upon its adoption.
