Minutes

The meeting was called to order at 12:05 PM, by Mr. David Bobo, Board President. The following board members were present: Ms. Peg Hill, Vice President, Mr. Jimmy Bice, and Mr. Brian Boatman. Mrs. Amber Polk was absent, as well as our Superintendent, Dr. Lewis Brooks.

Mr. Rick Vines gave the Invocation, and Mr. John Gwin led the Pledge of Allegiance.

Upon recommendation of the Superintendent, a motion was made by Mr. Boatman, seconded by Ms. Hill, and unanimously approved the July 18, 2023, Board Meeting Agenda as presented.
