Acorn High School recognizes that a child's education is a responsibility shared by the school and family during the entire time the child spends in school. To support the goal of the school to educate all students effectively, the school and parents must work as knowledgeable partners.

Acorn High School's Parent and Family Engagement Plan shall include programs and practices that enhance parental involvement and reflect the specific needs of all students and their families.

Acorn High School acknowledges that parents play an integral role in assisting student learning. To help the parents, students and schools team and partner together to best assure the academic successes of the students, "Parental and Family Engagement Meetings" will be scheduled. All meetings, including Open House and Parent/Teacher Conferences and Title I meetings, will be advertised in the local newspapers, on the school Facebook page, the school website and on the local radio station to welcome parents and/or guardians.

The district will designate two (2) Parent/Teacher Conferences each school year. The dates for the 2018-2019 school year are October 18th and March 14th. Other planned meetings and workshops are as follows: August 14th, Smart Core meeting, Public Meeting, Title I Public Meeting and Open House, September 11th District/School Level Parent Engagement Planning Meeting, September 26, Parent Involvement Plan/Title I Planning/District ACSIP Meetings, May 2nd, Parent Involvement Plan Review, Professional Development Plan Review, and ACSIP Peer Review, and Spring 2019, Title I Planning Meeting and Closing the Achievement Gap Meeting.

Ouachita River School District shall provide no less than two (2) hours of professional development opportunities for teachers every four (4)

years, which may be included in the minimum number of hours required, designed to enhance understanding of effective parental involvement strategies.

Ouachita River School District shall provide no fewer than two (2) hours of professional development opportunities for administrators every four (4) years, which may be included in the minimum number of hours of professional development required, designed to enhance understanding of effective parent involvement strategies, and the importance of administrative leadership in setting expectations and creating a climate conducive to parental participation.

Teachers and staff members will work with parents to refine the Title I Student/Teacher/Parent/Principal's Compact. The compact will outline how each stakeholder shares the responsibility for improving student academic achievement. The compact will be completed at the beginning of each year and placed on file at the school.

Acorn High School will involve parents in the planning processes of Title I, Title IIA, Title IVA and other such programs.

An alumni advisory board will be created to provide advice and guidance for school improvement.

Acorn High School and the Ouachita River School District shall designate at least one (1) certified staff member to serve as a parent facilitator to organize meaningful training for staff and parents promoting and encouraging a welcoming atmosphere to parental involvement in the school and to undertake efforts to ensure that parental participation is recognized as an asset to the district. To support responsible parenting, the principal will designate an area to be used as the Parent Center. Parenting books, magazines, educational

information, and other useful materials will be provided. The location of the Parent Resource Center will be announced annually at the Title I Parent and Family Engagement Meeting and the Public Meeting.

Informational packets will be developed, printed and distributed to parents at the beginning of the school year. The packets will provide parents with a student handbook, schedule of all events, how they may obtain information about the status and progress of their children, volunteer work, and how they may become involved in the education process of their children.

The process for parents to follow to resolve concerns will be placed in the Student/Parent Handbook, distributed to all parents, and made available in the school office.

Ouachita River School District, Acorn High School, parents and community will develop a parental and family engagement plan addressing the needs of the students and their parents. The plan will be reviewed and updated annually. The revised and/or updated Parent and Family Engagement Plan will be available in the building principal's office or can be viewed on the district web-site.

To welcome parents into the school and to seek parental support and assistance, the school or district shall not have any school policies or procedures that would discourage a parent from visiting the school. A parent volunteer survey will be sent home and a volunteer resource book, listing the interests and availability of volunteers, will be made available for school staff members' use.

To encourage parents to participate as full partners in the decisions that affect his or her child and family, the school and/or district shall sponsor seminars to inform parents of high school students how to be involved in the decisions affecting course selection, career planning, and preparation for post-secondary opportunities. Other activities
