10. BOARD REPORTS

-Mr. Shasky asked regarding the bleachers that were recently installed. They were used for the first time at our last assembly. It was nice to have, although it doesn't fit all our students, only 104. Mrs. Smith commented on Bingo night hosted by Parents Club. SHe said it was awesome and lots of fun. Mr. Torres stated that is was a success even though it wasn't as busy as the last one. Mr. Torres also commented that Trunk-or-Treat will be on Oct. 28th and Mystery Movie Night will be on Nov. 11th. Mr. Torres attended the ACES showcase last week and he said it was nice to see students up on stage.

11. PRESENTATIONS AND REPORTS

- Passing of long-time Le Grand Elementary staff member, Mrs. Debbie Stickles- Mr. Borba request a moment of silence in memory of Mrs. Stickles, who passed away due to health complications. She served our district for 29 years and the school would like to honor her by displaying a plaque dedicating the school kitchen to her. The board was in agreement.
- Parking Lot/Traffic Safety Discussion Board- Mr. Valladao stated it would be a good idea to encourage parents to drop off students at back parking lot. Back parking lot is under utilized. Another option would be to make Le Grand Rd. a yellow zone the sidewalk closest to the street. Mr. Torres stated that if the front parking lot opened up to allow a drop off lane, it would create a safety issue for students. Mr. Chavez asked if the opening of the front parking lot to a drop off lane had caused a hazard in the past. Ms. Banaga stated that a student did almost get run over. Parents were coming from both entry and exits to drop off students. After that incident, the board had decided to close the parking lot, so it has been some time since the front parking lot was open for drop-offs. Mrs. Smith commented that it would be a good idea to drop off students at the back parking lot. It would also be a good idea to have as many teachers park in the back too. Mr. Borba said that there may be a signal installed at the intersection, and perhaps adding a turning lane at Le Grand Rd. He stated he would be sending out a ParentSquare message to parents encouraging them to drop off students at the back parking lot. Unfortunately there is no supervision at the back, so the school may need to hire a classified staff to supervise. It would also be great if we had more law enforcement presence.

Mrs. Gonzalez reported on the work going on on campus. 1st grade just completed writing an informative paragraph. 3rd grade is excited about their trip to the pumpkin patch. 5th grade is rocking the podcast, and they finished reading Among the Hidden. 6th grade is selling Halloween grams, and working on

multiplying and dividing whole numbers and decimals. 8th graders are analyzing the Articles of Confederation and investigating the Constitutional Convention. 7th grade is reading about all the different parts of the brain.
