WHEREAS on February 11 2016, the Englewood Board of Education (hereinafter referred to as the "Board") approved merit action plans for the Superintendent for the 2015-2016 school year consisting of three (3) quantitative merit criteria and two (2) qualitative merit criteria and will submit same to the Executive County Superintendent for approval in accordance with N.J.A.C 6A: 23A-3.1(e) 10-11 (hereinafter referred to as "Merit Bonus Goals"); and

WHEREAS, the Board has created a goal for the Superintendent and determined that he will be required to increase parent communication and satisfaction by creating a monthly roundtable where parents will be part of the strategic planning of the district. We will plan on titling these meetings "coffee with the Superintendent". Some of the meetings will be held at night and others during the day. The purpose is to increase community relations, which will create "buy in" from key stakeholders. this is a qualitative merit bonus of 2.5% of his annual salary in the amount of \$4,187.50; and

WHEREAS, the Board has created a goal for the Superintendent and determined that the Superintendent will facilitate the development of a new student handbook, and a new teacher handbook. These new informational items will allow for the students and parents to completely understand the scope of all the responsibilities of the Englewood Public School District as well as their own. With measurable behavior goals and academic goals, all of the children will then be able to focus on their own academic program. This focus will allow the students and teachers the ability to identify a "game plan" for the success of all of the children who attend Englewood Schools. This is a quantitative merit bonus of 3.33% of his annual salary in the amount of \$5,527.5; and

WHEREAS, the Board has created a goal for the Superintendent will be to create relationships with Higher Education institutions. The goal of the Englewood Public School district is to have a minimum of three relationships with universities. These relationships would allow for the sharing of resources, including curriculum, staff and credit sharing. This is a qualitative goal thereby entitling him to a qualitative merit bonus of 2.5% of his annual salary in the amount of \$4,187.50 and

WHEREAS, the Board has created a goal for the Superintendent who will create a tutoring program for students identified in grades 4-8 who fall into the categories "non-proficient" as indicated on the Star assessments. The program will include 5 students per teacher instruction in both Language Arts and Math. The tutoring program will be a minimum of two hours per week for each student. Traditionally the programs in the Englewood District have not been well attended at approximately 25 students. We are looking to solicit parents and have at least 150 children in each building to participate. We are communicating with parents to encourage participation and offering services with fliers and personal contact. Additionally, we are offering childcare for those students who are responsible for younger siblings. This will eliminate a stumbling block for many students, a quantitative goal thereby entitling him to a qualitative merit bonus of 3.3% of his annual salary in the amount of \$5,527.50; and

WHEREAS, the Board has created a goal for the Superintendent to create an organizational chart that will develop more lines of communication among the district. Currently there are five different organizational charts used in the district. The new organizational chart will merge the 5 charts into 1. By creating the new organizational chart it will create, matching it with job descriptions, this will assure that each department has accountability. This will insure that a single shared vision will be articulated throughout the district. This is a quantitative goal thereby entitling him to a quantitative merit bonus of 3.33% of his annual salary in the amount of \$5,527.50; and

NOW, THEREFORE, BE IT RESOLVED that the Board hereby approves the aforementioned proposed merit bonuses for the 2015-2016 school year subject to approval by the Executive County Superintendent.

#### 7510 USE OF SCHOOL FACILITIES

The Board of Education believes the school facilities of this district should be made available for community purposes, provided that such use does not interfere with the educational and co-curricular programs of the school district. For the purpose of this policy, "school facilities" also includes school grounds.

The Board may permit the use of school facilities when such permission has been requested in writing and has been approved by the Superintendent or designee. The Board reserves the right to withdraw permission after it has been granted in the event circumstances change requiring such school facilities or school grounds will be needed for a school district purpose or due to a school closing due to weather or other emergency. Priorities will be given to Englewood-based organizations or events with the greatest benefit to Englewood citizens.

In weighing competing requests for the use of school facilities, the Board will give priority to the following uses:

- Uses and groups directly related to the schools and the operations of the schools, including pupil and teacher groups;
- Uses and organizations indirectly related to the schools, including the P.T.A., P.T.O., Home-School Association, and other school/parent-related organizations;
- Departments and agencies of the municipal government;
- Governmental agencies;
- Community organizations formed for charitable, civic, social, or educational purposes;
- Community political organizations;
- Community religious groups;
- Private groups and organizations;

the provisions of N.J.S.A. 18A:40-41.5, the school district shall not be liable for the injury or death of a person due to the action or inaction of persons employed by, or under contract with, a youth sports team organization that uses school facilities or operates on school grounds if the youth sports team organization provides the school district proof of an insurance policy in the amount of not less than \$50,000 per person, per occurrence; insuring the youth sports team organization against liability for any bodily injury suffered by a person. The youth sports team organization must also provide a statement of compliance with the school district's Policy and Regulation 2431.4 - Prevention and Treatment of Sports-Related Concussions and Head Injuries.

For the purpose of this Policy, a "youth sports team organization" means one or more sports teams organized pursuant to a nonprofit or similar charter or which are member teams in a league organized by or affiliated with a county or municipal recreation department.

**Regulations Governing Use** 

The Superintendent or designee shall develop regulations for the use of school facilities; such regulations shall be distributed to every user of the facilities and every applicant for the use of school facilities. Permission to use school facilities shall be granted only to persons and organizations that agree to the terms of Policy and Regulation 7510, the requirements as outlined in the use of school facilities application, and in accordance with the terms outlined in the approval granted by the school district.

Organizations may request a waiver of established fees in instances in which the event provides a direct benefit to the students of the school district or the community. The direct cost of personnel, supplies, and consumable materials associated with the use of the facility must be approved by specific resolution by the Board of Education.

The Superintendent or designee is authorized to use discretion in levying fees against city-based non-profit groups or schools, the regulation will be specify the criteria of any waiver or reduction of fees.

#### R 7510 USE OF SCHOOL FACILITIES

Rental fees and requirements for all buildings shall be adopted and approved annually by the Englewood Board of Education.

The Business Administrator or designee shall oversee the facility rental process. The process shall include the following:

- 1. Acceptance of facility use applications. Applications must be accepted 30 days prior to event.
- 2. Review of application and any fee waiver requests.
- 3. Create a contract with renter and ensure all required insurance certificates, hold harmless agreement and any other documentation required has been submitted prior to rental.
- 4. Any contracts that request the use for a period of more than one month and/or a total rental fee amounting to \$3,500.00 shall be approved by the BOE.
- 5. All rental payments are to be made payable to the Englewood Board of Education via check or money order and submitted to the Business Office. All payments must be received by the first of the month for recurring events or 30 days prior to the event if a one-time use event

The Business Administrator has the authority to waive or reduce fees per the following criteria:

- 1- Not for Profit Organizations eligible for a 20% discount. Must provide Non-Profit Certificate to receive discount.
- 2- The Englewood Recreation Department shall be waived all fees.
- 3- Any and all school-sponsored events shall be waived all fees.
- 4- Any organization may request a waiver or reduction in hourly rental fee when, the event provides a direct benefit to the students of the district. The organization shall submit documentation of the direct benefit to the students. The rental fee can be reduced by the participation rate of Englewood resident students or other documented reasonable basis. However, no group shall be waived from custodial fees, air conditioning costs and when school-based personnel are required to be onsite during the event.

#### Title: OUTSTANDING FOOD SERVICE CHARGES

#### [See POLICY ALERT No. 206]

The Board of Education understands a student may forget to bring breakfast or lunch, as applicable, or money to purchase breakfast or lunch to school on a school day. When this happens, the food service program will provide the student with breakfast or lunch with an expectation payment will be made the next school day or shortly thereafter. However, there may be circumstances when payment is not made and a student's school breakfast/lunch bill is in arrears. The school district will manage a student's breakfast or lunch bill that is in arrears in accordance with the provisions of N.J.S.A. 18A:33-21 and this Policy.

Effective the 2015-2016 school year if a student's school lunch or breakfast bill is in arrears, the Business Administrator or designee shall contact the student's parent to provide notice of the amount in arrears and shall provide the parent a period of ten school days to pay the full amount due. If the student's parent does not make full payment to the Principal or designee by the end of the ten school days, the Principal or designee shall again contact the student's parent to provide a second notice that their child's lunch or breakfast bill is in arrears. If payment in full is not made within one week from the date of the second notice, the student

X\_\_\_\_\_ will be provided a basic lunch that will contain the essentials in balanced nutritional selections as prescribed by the Bureau of Child Nutrition Programs, New Jersey Department of Agriculture beginning the eighth calendar day from the date of the second notice.

A parent who has received a second notice their child's lunch or breakfast bill is in arrears and who has not made payment in full within one week from the date of the second notice will be requested to meet with the Principal or designee to discuss and resolve the matter. In the event the parent refuses to meet with the Principal or designee or is unable to resolve the matter, the Business Administrator or designee will report the parent's failure to provide breakfast or lunch, as applicable, for the child, to the New Jersey Department of Children and Families, Division of Child Protection and Permanency.

This provisions of N.J.S.A. 18A:33-21 and this Policy will be made available to parents of all children in the school district in a manner as determined by the Superintendent.



PRINCIPAL ELBERT'S Additional Notes: It is unclear whether this is an effort by the State to justify the PARCC by citing student non-compliance in an effort to take the focus away from the real question that begs--- What is the validity of the PARCC and how reliable is the data that is to be gotten from the test. With numerous states dropping PARCC (see the chart included below) and reluctant to adopt the Common Core, notably Massachusetts's in November, 2015, I am not certain what the future holds for New Jersey and the use of PARCC.

In the same way that I would like to see Dwight Morrow High School develop Common Formative Assessments in core subjects that are aligned with the Common Core instead of having our students sit for Star Testing, this will be an antecedent for what numerous states are now doing to replace PARCC.

Additionally, it is the goal of the high school administrative team to afford students alternatives to PARCC, as evidenced by the increased number of students taking the PSAT and SAT as well as the Accuplacer, ASVAB, and other options. By demonstrating proficiency on these assessments, even fewer high school students will need to sit for the PARCC, making the mandatory participation even more challenging to require of our students and their families.





Yes. Extraordinary Aid can be utilized to fund Special Education software in New Jersey. While these funds can be used to fund IEP Direct, it should be noted that as a form of State Aid, Extraordinary Aid is subject to the annual appropriation by the Legislative Branch of government in New Jersey and approval of the Governor. Also, the Extraordinary Aid funding amounts can greatly vary from one fiscal year to another depending on the mix of students.

# 3. What accounts can the software be funded by in the General Account, if the district chose this approach?

There are a number of options that are appropriate. Many school districts utilize the General Account (Fund 12), with the appropriation being applied to Pupil Personnel Services.

#### 4. Can software be funded as a technology expense?
