## AN ACT

- 1 Amending the act of March 10, 1949 (P.L.30, No.14), entitled "An
- act relating to the public school system, including certain
- provisions applicable as well to private and parochial
- schools; amending, revising, consolidating and changing the
- laws relating thereto," in preliminary provisions, providing
- for mandate waiver program.
- 7 The General Assembly of the Commonwealth of Pennsylvania
- 8 hereby enacts as follows:
- 9 Section 1. The act of March 10, 1949 (P.L.30, No.14), known
- 10 as the Public School Code of 1949, is amended by adding a
- 11 section to read:
- 12 <u>Section 129. Mandate Waiver Program. -- (a)</u> Except as
- 13 otherwise provided in this section, a governing body may adopt a
- 14 resolution to apply to the department for a waiver of one or
- 15 more provisions of this act, regulations of the State Board,
- 16 <u>standards of the secretary, policies or quidance of the</u>
- 17 department or any other provisions of law permitted to be waived
- 18 under this section to enable the school entity to improve
- 19 instructional programs or operate in a more effective, efficient

- 1 or economical manner.
- 2 (b) The application for a waiver shall be submitted in a
- 3 manner and on a form established by the department. The
- 4 <u>application may only require applicants to:</u>
- 5 (1) Specify the provisions of this act, regulations of the
- 6 State Board, standards of the secretary or policies or guidance
- 7 of the department for which the applicant is seeking a waiver.
- 8 (2) Include the reasons why the waiver is being requested.
- 9 (3) Provide supporting data or information to explain the
- 10 benefits expected to be obtained as a result of the waiver.
- 11 (c) Each application for waiver shall be adopted by a
- 12 resolution of a governing body at a regularly scheduled meeting
- 13 of the governing body. Approval from the department shall be
- 14 required prior to implementing the waiver.
- 15 (d) The department, in considering each waiver application:
- 16 (1) May not impose any additional requirements on the waiver
- 17 applicant other than the requirements specified in this section.
- 18 (2) Shall approve any waiver application that:
- 19 (i) Complies with the application process and provides all
- 20 information required in the application form developed by the
- 21 department under subsection (b).
- 22 (ii) Does not conflict with a provision of Federal law or
- 23 regulation or any other law or regulation that is not permitted
- 24 to be waived under this section.
- 25 (e) The department shall have thirty (30) days from receipt
- 26 of the waiver application to issue a written approval,
- 27 disapproval or request modifications to the application. If the
- 28 department fails to act within that time period, the waiver
- 29 <u>application shall be deemed to be approved.</u>
- 30 (f) (1) If the department requests modification to or

- 1 disapproves the waiver application, the specific reasons for the
- 2 department's request or disapproval shall be transmitted to the
- 3 <u>waiver applicant.</u>
- 4 (2) If the department denies an application, the response to
- 5 the applicant shall include an explanation of any provision of
- 6 law, regulation of the State Board, standard of the secretary or
- 7 policies or quidance of the department that is not subject to
- 8 waiver under this section and would be violated if the
- 9 <u>application were granted.</u>
- 10 (3) The waiver applicant may submit a revised application
- 11 for a waiver in accordance with subsection (c).
- 12 (4) A waiver applicant may appeal a disapproval to the
- 13 <u>secretary pursuant to 2 Pa.C.S. Chs. 5 (relating to practice and</u>
- 14 procedure) and 7 (relating to judicial review). A waiver
- 15 applicant shall not be required to revise and resubmit the
- 16 <u>waiver application prior to appealing a disapproval.</u>
- 17 (q) A waiver shall remain in effect permanently unless
- 18 rescinded by the governing body or found by a court of competent
- 19 jurisdiction to be in violation of subsection (d)(2)(ii).
- 20 (h) The following shall not be subject to waiver pursuant to
- 21 this section:
- 22 (1) The following provisions of this act: sections 106, 108,
- 23 110, 111, 111.1, 321, 322, 323, 324, 325, 326, 327, 328, 431,
- 24 436, 437, 440.1, 443, 513, 518, 527, 701.1, 708, 740, 741, 751,
- 25 752, 753, 771, 776, 785, 808, 809, 810, 1073, 1073.1, 1076,
- 26 1077, 1080, 1302, 1303, 1310, 1310.1, 1317, 1317.2, 1318, 1327,
- 27 1327.1, 1327.2, 1330, 1332, 1361, 1366, 1501, 1502, 1513, 1517,
- 28 <u>1518, 1521, 1523, 1526, 1546 and 1547, provisions prohibiting</u>
- 29 discrimination, Articles VI, VI-A, XI, XI-A, XII, XIII-A, XIII-
- 30 B, XIII-C, XIII-D, XIII-E, XIV, XVII-A and this section.

- 1 (2) The following provisions of 22 Pa. Code (relating to
- 2 education):
- 3 <u>Chapter 4 (relating to academic standards and assessment).</u>
- 4 <u>Chapter 10 (relating to safe schools).</u>
- 5 <u>Chapter 11 (relating to student attendance).</u>
- 6 Chapter 12 (relating to students and student services).
- 7 <u>Chapter 14 (relating to special education services and </u>
- 8 programs).
- 9 Chapter 15 (relating to protected handicapped students).
- 10 Chapter 16 (relating to special education for gifted
- 11 students).
- 12 Chapter 235 (relating to Code of Professional Practice and
- 13 <u>Conduct for Educators</u>).
- 14 <u>Chapter 711 (relating to services and programs for children</u>
- 15 with disabilities).
- 16 (3) For intermediate units, Article IX-A and 22 Pa. Code
- 17 Ch. 17 (relating to intermediate units).
- 18 (4) For area career and technical schools, Article XVIII and
- 19 22 Pa. Code Ch. 339 (related to vocational education).
- 20 (i) The department shall maintain and annually update a
- 21 listing of all approved waiver applications on the department's
- 22 publicly accessible Internet website. The listing shall include
- 23 the name of the school entity and the provisions of law,
- 24 regulation, standard of the secretary or policies or guidance of
- 25 the department for which waivers were granted.
- 26 (j) Nothing in this section shall be construed to supersede
- 27 or preempt any provisions of a collective bargaining agreement
- 28 in effect on the effective date of this subsection.
- 29 (k) As used in this section, the following words and phrases
- 30 shall have the meanings given to them in this subsection unless

- 1 the context clearly indicates otherwise:
- 2 <u>"Department." The Department of Education of the</u>
- 3 Commonwealth.
- 4 "Governing body." A board of school directors or other
- 5 governing authority of a school entity.
- 6 <u>"School entity." A school district, charter school, cyber</u>
- 7 <u>charter school, regional charter school, area career and</u>
- 8 <u>technical school or intermediate unit.</u>
- 9 <u>"Secretary." The Secretary of Education of the Commonwealth.</u>
- 10 "State Board." The State Board of Education.
- 11 <u>"Waiver applicant." A school entity that applies for a</u>
- 12 waiver under this section.
- 13 Section 2. This act shall take effect in 60 days.
