REGULAR MEETING August 14, 2017

Superintendent Schwan presented an update on the elementary school remodel project. Work is being completed in the 1992 addition/library. Custodians will begin moving items back into this space on Tuesday, August 15th. Work in other areas will be completed by the end of the week. An Architect and Engineer meeting will be held on Tuesday the 22nd to develop a punch list of items that need to be completed and/or corrected. School lunch will be served in the gymnasium as it has been in the past until the new addition is completed in October.

The following change orders to the elementary construction project were reviewed for consideration: a) CCO#003 with Muth Electric – add phone data cabling to Comm Room 054 for an increase of \$1,476 and b) CCO#009 with JDH Construction – change accent wall color in South Pod and patch masonry in restrooms for an increase of \$1,690.

The following topics were discussed in administrative reports: staff updates, staff in-service, bus repairs, facilities maintenance, new reading strategies, OST update, elementary special ed staff meeting, new student registration, back to school open house, joint FFA/FCCLA/FBLA student project and coop membership update.

Moved by Rix, second Weismantel to approve Sarah Schuster as Volunteer Assistant Volleyball Coach for the 2017 season. Motion carried.

Moved by Weismantel, second Gengerke to approve Seth Erickson as Volunteer Assistant Football Coach for the 2017 season. Motion carried.

Moved by Gengerke, second Kjelden to approve request from Langford Area School District to pick up students in Bristol and Andover for the 2017-18 school year pursuant to SDCL 13-29-4. Motion carried.

The board acknowledged receipt of Public School Exemption #18-06 for a student in grade 6.
