## **Standing Committees**

Please note that in the December BA's report to the Board, Mr. Kaz has provided the annual committee interest survey for each Board member to complete and return. Please complete your preference sheets at your earliest convenience.

I will review each Board member's committee interest survey response sheets that indicate Board Member Committee preferences and review preferences with Mr. Zimmer, Board President. Please note that committees cannot be completed until the Board has reorganized in January. Therefore, the intention is to complete all committee recommendations immediately after reorganization in January and have the committees set for the February Board meetings. Until then, committees will remain the same through reorganization and January.

#### **Business and Financial**

Take a moment to review Mr. Kaz's December report. There is an update on the bond refinancing. Mr. Kaz and I participated in a conference call on December 1<sup>st</sup> with bond council and market specialists. The 'bottom line' is that council has determined it appropriate not to purchase the bonds on December 1<sup>st</sup> and to allow the market to 'settle' as the rates and indicators were simply not beneficial to the Board. Hence, we will continue to monitor the market and be in a position to act as soon as the market offers an incentive.

It is also important to note that NB has received its Preliminary Eligibility Costs (PEC) Letter from the Department of Education (DOE). However, there are some data points being questioned by the Architect and Mr. Kaz so we don't have final numbers at this time. It seems quite reasonable to believe that this process will be resolved for the January reorganization meeting.

# **Buildings and Grounds**

The Bus access road repair project is still under review. At this time the engineer is planning to do a temporary repair to the access road with the cost to be covered by the engineer. The plan is to have this in place by the end of December. Next, the engineer is recommending that we plan for a final, permanent, repair in the spring, during the spring break or perhaps at the start of summer vacation. The motivation to delay the project is aided by the fact that the engineer would like to study how the road performs these next few months before a final strategy outlining more permanent remediation is decided. We have notified the Board's solicitor of the matter and we will keep him apprised of any issues as they develop.

As Superintendent, I am not disappointed in the delay of the access road repair. Busses and trucks have full access of the road and it's reported that the degree of damage is not increasing. Therefore, the option to avoid the tremendous inconvenience of shutting down the road for two weeks while school is open is one that I will certainly recommend.

## **Negotiations**

In November, the New Jersey Acting Commissioner presented a strategy to 'adjust' the Superintendent's Salary Caps in New Jersey. In recent weeks, the Burlington County Times has run several stories on the salary caps. In fact, the October 2, 2016 BCT featured me along with several other Superintendents in Burlington County who are currently 'under the cap. ## Personnel

As noted in November, the Director of Student Personnel Services has resigned her position to take an administrative post in Moorestown. A 'transition plan' is being prepared until the position can be filled. The job opening is posted and applications have started to arrive via Applitrack, a state and national search management tool in which NB actively participates.

In addition, please note that the private secretary to the Director of Counseling has resigned her position due to personal reasons. The combination of losing both the director and the private secretary in this area is going to create challenges as this administration looks to fill these positions. I have confidence in the resilience of the administrative team.

Next, the high school Assistant Principal resigned her position in November and I am pleased to report that her replacement is on the December Board agenda for consideration.

I appreciate the good work of the search committee that included both principals, an assistant principal, director, and faculty member.

Finally, please note that there is a personnel committee meeting scheduled for Thursday, January 26<sup>th</sup>. This is the annual committee meeting. At this meeting, NB's building principals will review all non-tenured teachers and discuss any personnel concerns. In addition, they will prepare initial recommendations for renewals scheduled in May. Moreover, the Superintendent, Assistant Superintendent, and Business Administrator will present performance reviews of NB's Directors, Principals, and Assistant Principals.

# **IPSC Update**

Recently, the Burlington County Times wrote a story on the Interdistrict Public School Choice (IPSC) Program underway in several schools in Burlington County. The following is for your information only. NB's IPSC program continues to provide life-changing experiences to students interested in the study of Agriscience. The following is from BCT:

"Last May, the Department of Education asked Choice parents to fill out an online survey to help the department understand the parent's reasons for enrolling their children in an IPSC program and their level of satisfaction with the program. The aggregated results from the survey are provided below.

#### **May 2016 Choice Parent Survey Results:**

- 1019 parents responded from 80% of all Choice districts.
- 96% of parents who responded to our survey stated they were either <u>satisfied (14%) or very</u> satisfied (82%) with their students' Choice district.
- The most important reasons parents cited for their students attending a Choice district were, in rank order:
  - Higher school performance: #1
  - More rigorous or diverse academic programs:#2
  - Better climate and culture: #3
- Parents selected the following ways in which the Choice school's climate and culture are superior to that of their child's resident school:
