- Approval of Budgetary Transfers – It is recommended that the Board authorize the necessary budgetary transfers to close the 2018-2019 fiscal year in compliance with the accounting requirement of the Commonwealth of Pennsylvania on June 30, 2019.

- Approved BEA Resolution 06-13-19-05 authorizing the incurring of nonelectoral debt by the issuance of a General Obligation Note in a principal amount of \$8,530,000: covenanting to pay, and pledging all available taxing power for the payment of, the Note; fixing the form, interest rate, maturity, redemption and other provisions for the payment thereof; authorizing the acceptance of a proposal for the purchase of the note; authorizing a filing of required documents with the Department of Community and Economic Development; ratifying and directing certain actions of Officers; and making certain other covenants and provisions in respect of the Note.
