

CONSTITUTION

PREAMBLE

We, the members of the Barrington High School athletic teams, in order to utilize the skills of teamwork, cooperation and socialization within the activities of the Athletic Department and the activities designed by the group to foster these skills do hereby establish the constitution for the **EAGLES ATHLETIC CLUB** of Barrington High School.

ARTICLE I

NAME

The name of this organization will be the **EAGLES ATHLETIC CLUB**.

ARTICLE II

PURPOSE

SECTION 1. The purpose of this organization will be:

- a. To promote sportsmanship
- b. To assist in athletic functions
- c. To sponsor activities which promote cooperation between the high school and the community
- d. To promote leadership
- e. To provide experiences for athletes to be socially involved outside of their sport activities
- f. To encourage participation in more than one sport
- g. To encourage community service by student athletes

ARTICLE III

MEMBERSHIP

SECTION 1. Membership will be open to any boy or girl who has been awarded one varsity letter or two JV letters or two numerals.

SECTION 2. Members must be active (unless disabled) in at least one sport during the school year.

SECTION 3. A member who does not remain in good standing will be recommended for dismissal.

SECTION 4. Members will make a commitment to attend all meetings and involve themselves with the projects, activities and ideas of the club.

ARTICLE IV

OFFICERS

SECTION 1. The officers will be two Presidents (both seniors, one male, one female), two Vice Presidents (both juniors, one male, one female), one Secretary (senior, male or female), one Treasurer (senior, male or female), Committee Chairs (Activities, Publicity and Fund Raiser Chair: senior). Committees will consist of volunteers, at least one person from each class if possible.

SECTION 2. Officers will be elected in September and hold that office for one school year.

ARTICLE V

DUTIES AND POWERS OF THE OFFICERS

SECTION 1. The President:

- a. Will preside at all meetings
- b. Will call extra meetings when needed
- c. Will assume all extra responsibilities which may arise during the tenure of office

SECTION 2 The Vice President:

- a. Will preside at all meetings in the absence of the president
- b. Will attend all meetings
- c. Will assist the president in all extra responsibilities which may arise during the tenure of office

SECTION 3. The Secretary:

- a. Will attend all meetings
- b. Will keep an accurate record of all transactions of the club
- c. Will maintain a complete report of the club's accomplishments
- d. Will take attendance at each meeting

SECTION 4. The Treasurer:

- a. Will attend all meetings
- b. Will keep an accurate record of all expenditures and income
- c. Will collect dues set at one dollar (\$1.00) per meeting and to total seventeen dollars (\$17.00) per year. Dues must be paid in full by January 15 of the current school year

SECTION 5. The Social Chair:

- a. Will attend all meetings
- b. Will be responsible for all of the social activities in which the club takes part
- c. Will be responsible for activities before and after the scheduled meeting

SECTION 6. The Activities Chair:

- a. Will attend all meetings
- b. Will be responsible for the coordination of extra activities of the group
- c. Will be responsible for the planning of refreshments for athletic awards programs

SECTION 7. The Publicity Chair:

- a. Will attend all meetings
- b. Will be responsible for posting any important meetings or activities for members
- c. Will work with all officers to report any noteworthy news

SECTION 8. The Fund Raiser Chair:

- a. Will attend all meetings
- b. Will be responsible for regulating fund raisers in which the club chooses to participate
- c. Will be responsible for keeping a record of all information involving the fund raising activity

ARTICLE VI

ADVISOR

SECTION 1. The advisor

- a. Will attend all meetings
- b. Will help the officers understand and carry out their duties

ARTICLE VII

MEETINGS

SECTION 1. Meetings

- a. Will be held twice each month, the date, time and place to be determined by the membership. Special meetings may be called by the president or by request of at least twenty (20) members of the club.
