

# C O N S T I T U T I O N

## PREAMBLE

We, the members of the Barrington High School, in order to foster an awareness of and a concern for the environment, do hereby establish this constitution for The Environmental Club of Barrington High School.

## ARTICLE I

### NAME

SECTION 1. The name of this organization will be The Environmental Club of Barrington High School.

## ARTICLE II

### PURPOSE

SECTION 1. The purpose of this organization will be:

1. To promote the improvement of our school building
2. To provide activities for the benefit of the community
3. To provide funds for environmental awareness and improvement
4. To provide a foundation for future classes of this high school to continue environmental pursuits

## ARTICLE III

### MEMBERSHIP

SECTION 1. The Environmental Club will be composed of any interested students attending Barrington High School.

SECTION 2. Qualifications:

1. The members will make a commitment to attend all meetings and involve themselves with the projects and ideas of the club

ARTICLE IV

OFFICERS

- SECTION 1. The officers of the Environmental Club will be a president, a vice-president (or two co-presidents), a secretary, and a treasurer.
- SECTION 2. Election: Officers will be elected in September of the current year.
- SECTION 3. Term of Office: The officers will hold office for one school year.

ARTICLE V

DUTIES AND POWERS OF THE OFFICERS

- SECTION 1. The president:
1. Will preside at all meetings in the absence of the president
  2. Will call extra meetings when needed
  3. Will assume all extra responsibilities which may arise during his/her tenure of office
- SECTION 2. The vice-president:
1. Will preside at all meetings in the absence of the president
  2. Will attend all meetings
- SECTION 3. The secretary:
1. Will attend all meetings
  2. Will keep an accurate record of all transactions of the club
  3. Will furnish, at the end of the year, a complete report of the club's accomplishments
  4. Will call roll at each meeting
- SECTION 4. The treasurer:
1. Will attend all meetings
  2. Will keep an accurate record of all expenditures and income
- SECTION 5. The members of the Environmental Club:
1. Will attend all meetings
  2. Will share ideas and initiate, plan, and participate in all club activities and events

ARTICLE VI

DUTIES OF A SPONSOR

- SECTION 1.    1. Will attend all meetings  
                 2. Will give advice and assistance when needed  
                 3. Will maintain regular communication with the  
                      principal regarding all club activities

ARTICLE VII

DATE AND PLACE OF MEETING

- SECTION 1.    The Environmental Club will meet on a regular basis.  
                 The dates and times of meetings will be determined at  
                 the start of each school year.

ARTICLE VIII

DATE EFFECTIVE

- SECTION 1.    The constitution will be effective immediately after  
                 ratification by the School Committee.
