SUPERINTENDENT REPORT

- SAT results for the current 11th graders have arrived. The students took the PSAT in the fall. Both tests are graded on the same scale, which means growth can be measured. 62% of the students improved in English, 68% of the students improved in Math, 43% of the students improved in both subjects. Scores are close to the State of Ohio averages.
- The meeting of the West Milton Rotary club was hosted by Milton-Union Schools today. Mark Lane talked about the District's agreement with Premier Health and the strength and conditioning program.

Expenditures were 4.14% less than projections. Salaries are trending 3.1% less than projected due to teacher staffing changes throughout the year. Community school enrollment continues to be lower than expected.
