

# What should reading instruction look like for students in grades K-3?

Researchers estimate that 95% of students can learn to read when presented with high-quality reading instruction that is aligned with the science of reading.



# High-Quality Instruction Is:

- explicit
- systematic
- informed by data
- individualized

# High Quality Instruction Includes:

- phonemic awareness
- phonics
- fluency
- vocabulary
- comprehension
- oral language

The purpose of high-quality reading instruction is to empower all students to become critical readers who have the foundational skills and word knowledge to read and understand increasingly complex text.

Name of Assessment	Time of Year	Purpose
DIBELS 8 Benchmark 1 (BOY)	Between the 6th and 21st days of school year	Establish a baseline of a student's skills in relation to foundational reading skills.
NC 3rd grade Beginning of Grade (BOG) Assessment	Between the 11th and the 15th day of the school year	Establish a baseline of a beginning 3rd grade student's overall reading skills.
The BOG differs from DIBELS 8 in that it provides an overall picture of a student's ability to access third grade level standards.  DIBELS 8 focuses on ensuring students master the foundational reading skills that they need to become proficient readers through benchmarks and ongoing progress monitoring.		
DIBELS 8 Benchmark 2 (MOY)	Between the 80th and 100th days of the school year	Monitor a student's reading skills.
DIBELS 8 Benchmark 3 (EOY)	Between the 155th and 170th days of the school year	Monitor a student's reading skills.
NC 3rd Grade End of Grade (EOG)	During the last 10 days of the school	Measure student performance on the 3rd grade goals, objectives, and grade-level

## **Good Cause Exemptions**



If your third grade student does not demonstrate third grade reading proficiency they may be exempt from mandatory retention in third grade for good cause.

### Children with Disabilities

Students with disabilities whose individualized education program indicates (i) the use of the NCEXTEND1 alternate assessment, (ii) at least a two school year delay in educational performance, or (iii) receipt of intensive reading literacy interventions for at least two school years.

# What are reading camps?

If your child does not show proficiency through the multiple pathways offered by the end of third grade, they will be invited to participate in reading camp.

Designed to provide evidence based reading instruction.



There is no cost to parents.



Attendance in reading camps is not mandatory.



Enrollment is encouraged for continued reading support.



# What if my child does not meet reading camp goals?

Your child will be placed in one of three classes based on their needs and the capacity of the school.

#### Retained in 3rd Grade

- 3rd grade standards and curriculum
- 3rd grade EOG

#### 3rd/4th Transition Class with Reading Retained Label

- 4th grade standards and curriculum
- 4th grade EOG

#### 4th Grade Accelerated Reading Class

- 4th grade standards and curriculum
- 4th grade EOG
- 2 years growth in 1 year
