Citizens' Inquiries & Comments Pertaining to Agenda Items

Mrs. Norma Cusik asked if board motion B-1 is for residents. The Red Cross representative stated it is an agreement between the district and the Red Cross. If needed Red Cross will call on the school district for two buildings to use for shelters. Generally they like to put people up in hotels. In situation where will call the district for shelter in this township for disaster for example, if there was a fire that wipes out a block of houses, the Red Cross will try to get a shelter that is as close as possible to their home. They cannot turn people away. If there was an mass disaster or emergency for people who not residents emergency management would activate the shelter. The Red Cross would activate a shelter for a Level 1 disaster. Mrs. Cusik referred to the hurricane Sandy where people were without electricity for a week or more. If there was a wide spread power outage the Red Cross is not in charge of the situation. The schools currently have generators with limited capacity. Mrs. Cusik asked how the community would be notified which buildings will be utilized for disasters. The community would be notified through WFMZ. Mr. Roth stated that the schools' generators are not powerful to operate for full capacity, only enough to get people out for emergency situations with the use of emergency lighting only.

Mrs. Cusik gave the board handouts prior to the meeting. The library is now distributing museum passes and it is free of cost. Children services story time will end mid-April. The library is starting to work on their summer reading program. The fourth annual "A Novel Affair Gala" raised \$16,562 for the library. QNB bank is sponsoring the Lehigh Valley Iron Pigs and as part of that sponsorship, will also be donating money for the library. Through the Batting for Books campaign, QNB will donate \$25 to APL for every double hit by the Iron Pigs. Last year the library received \$3,000. There are 4,012 registered Salisbury borrowers.

E. PSBA Legislative __Policy Council_

Mr. Frankenfield stated there was a meeting conflict but at the last meeting a Skills USA presentation was held to recognize five students from Salisbury.

Mr. Bruchak stated Senate Bill 1316 (Sen. Pat Browne)-Amends the Public School Code to implement the recommendations of the Special Education Funding Commission. The bill provides a formula for the distribution of new special education dollars, makes changes to the special education charter school tuition calculation, modifies the Special Education Contingency Fund and allows approved private schools to recoup money appropriated but not used in the prior year. This bill is identical to House bill 2138.

House Bill 1738 (Rep. Bernie O'Neill)-Amends the Public School Code to create a Basic Education Funding Commission to examine current basic education funding and make recommendations on a new formula for the distribution of basic education funding. The Commission's recommendations must be provided within one year of the effective date of the bill.

This week state Budget Secretary Charles Zogby announced that more than \$779 million in gaming revenue will be available for property tax relief in 2014. The average statewide property tax reduction for each household is expected to be about \$200 this year. Final figures will be provided in early May, when counties report the number of homeowners who have signed up for their share of property tax relief.

The Senate Finance Committee is tentatively scheduled to conduct a public hearing on Senate Bill 76 (Sen. Argall, R-Schuylkill), a proposal to eliminate property taxes and shift a significant burden of funding public schools onto various other state and local taxing mechanisms.

House Bill 2063 (Rep.Maloney, R-Berks) requires all school entities and independent contractors of school entities to conduct detailed employment history reviews prior to offering employment to any applicant for a position involving direct contact with children.

G. Superintendent

MR. Dovico stated the Keystone AP testing are approaching and the high school is wrapping up dual enrollment. They have 41 students receiving over 300 college credits this year. Keystones will take place mid-May. Mr. Parliman stated the middle school is finishing PSSA Math, Reading and Writing. Last week World Languages put on a world language fair for 7th grade students. Harry S Truman Elementary students traveled to Harrisburg to see the government in action. Western Salisbury Elementary's fifth grade will be going to Philadelphia. PTA will be holding a book fair at Barnes and Noble this Friday. WSE and HST's leadership days are in June. No Place for Hate visited WSE to discuss responsible use of social media and bullying. Mrs. Hartman said it is more powerful when older student talk to fifth graders. Mrs. Hartman stated the district should be really proud of the high school students who visited WSE. Both elementary schools finished report card conferences and both schools were visited by the SATORI music chamber, who demonstrated instruments and brought an artist who is drew an illustration of barges on the river. Mrs. Fuini-Hetten stated the district will be completing highly

qualifying Instructional Assistants and there are currently 10 students in VAST. She is beginning to look at summer academy and 113 staff completed assessment as to what they want to learn this summer. Dr. Ziegenfuss stated the last sets of surveys are coming to an end for TL2014. Next vision is TL2020 which will be shared at the operations meeting May 5. May 12 is the next curriculum meeting. That week is also social media week. PENSPRA recognized the district for excellent social media. State initiatives still have some work and teachers preparing for student learning objectives. The district is in the process of training teachers for PVAS verification process. Mrs. Perron-Jones stated teachers had to present IEPs and are currently making corrections and resubmitting. Interviewing all students leaving public schools by way of graduation or age of 21. Data is kept by PDE. Teachers working on summaries of performance. Next week the special education office is preparing for the transition audit. She will be attending a two day PAGE/ Gifted conference tomorrow and Friday. Early intervention students transitioning in welcoming into Salisbury within next the six weeks. Mr. Roth did have a strategic planning and Superintendent Parent Advisory Committee meeting planned for tomorrow but the meetings have been canceled. May 1 the state will release requirements for plans of strategic plans. Recognize this time of year begins to get difficult. There are a lot of connections that help to support a district such as the Allentown Public Library, Lehigh Valley Child Care, Paragon Transportation, St. Luke's/St. Christopher, Salisbury Education Foundation, District Solicitor, KidsPeace, Salisbury Township, Salisbury Township Police Department, Salisbury Press, EduSummit, PTAs, Booster Clubs, Community Services for Children, LCTI, LCCC, CLIU, and the other school districts that we partner with. Mrs. Ziegler added under student activities that the high school hosted the indoor percussion/twirling show. There were 46 schools/groups in attendance. She thanked the high school the cafeteria staff and the custodial staff who all worked hard.
