Mr. Mantz asked for clarification on the wording. The financing listed is for option #2. Mr. Roth said the understanding was we had to make a decision as to whether or not we were going to move forward and get pricing on equipment and so forth. Mr. Frankenfield said whatever decision we make that number will go into option #2. Item 2 amended.

B-3. Guaranteed Energy Savings Project Phase II Financing approve the financing for the Guaranteed Energy Savings Project Phase II with Municipal Capital for the terms of 15 years, fixed interest rate of 2.9%, annual payment not to exceed \$44,287.78 principal and interest. for the term of 10 years, fixed interest rate of 2.3%, annual payment not to exceed \$61,308 principal and interest.

Mr. Bruchak prefers the 10 year option, but we must go with 15 year option to remain budget neutral. The overall cost of the project is \$62,000 more if we go with 15 year financing vs. 10 year financing. Mr. Giordano felt for \$16,000 additional per year we should go with 10 year, but Mr. Mantz argued where do we get this from in the budget. Mr. Bruchak said we can probably take it out of the fund balance, which he doesn't anticipate we will have to eat into at all with this next budget. Item 3 amended.
