1ST ANNUAL ALL-SPORTS SEASON TICKET RAFFLE

Official Rules

- 1. **General**. By participating in the Tecumseh Athletic Fundraiser 2023-2024 All-Sports Season Tickets Raffle, entrants agree to be bound by these Official Rules and by the decisions of the Tecumseh Athletic Department, which shall be binding and final as to all matters related to the Raffle. The Raffle is subject to all applicable federal, state, and local laws.
- 2. <u>Prizes</u>. One (1) winner will be randomly selected by Tecumseh Athletic Department personnel from all eligible entries for a Prize. Winners will be determined by random selection (each selection is a "Draw").
- 3. <u>District Proceeds</u>. Proceeds of the Raffle will go toward the Athletic Department to help support all of our athletes of Tecumseh Public School.
- 4. **Eligibility**. The Raffle is open to everyone.
- 5. Purchasing Raffle Tickets. All purchases must be made through PAYK12 site. Raffle Tickets may be purchased as follows: one (1) ticket for one dollar (\$1). Please include your Name, Phone Number, E-mail. There are no discounts or complimentary Raffle Tickets. Raffle Tickets will be available for purchase on-line ONLY beginning at 12:00 AM CT Tuesday, August 15, 2023, Tuesday, September 22, 2023 at 12:00 AM CT (the "Raffle Period"). There is no limit to the number of Raffle Tickets an individual may purchase. Each entrant will receive a receipt corresponding to his/her purchased Raffle Tickets. Entries which are or appear to be tampered with are void. The Tecumseh Athletic Department and PAYK12 shall be the sole judge of the validity and eligibility of all entries. All Raffle Ticket purchases shall be final, and no refunds or replacements will be issued by the Tecumseh Athletic Department. Raffle Tickets are only valid for the drawing held in connection with the date of purchase.
- 6. <u>Raffle Tickets are Not Tax Deductible</u>. The IRS has taken the position that amounts paid for chances to participate in raffles, lotteries, or similar programs

- are not gifts and, therefore, the price of the entry does not qualify as a deductible charitable contribution.
- 7. <u>Prizes</u>. One (1) winner will be selected to receive one of the following prizes: two (2) All-Sports 2024-25 Season Home Game Tickets. Estimated Value \$500.00
- 8. <u>Selection of Winners</u>. On September 29, 2023, one (1) Raffle Ticket will be drawn by the Athletic Department to determine the winner of the Prize. The holder of any winning Raffle Ticket will be contacted by the Athletic Department via the contact information provided by such holder at the time of purchase.
- 9. Prize Claim. Within fourteen (14) days of the drawing, any prize claimant must notify the Superintendent and present the winning Raffle Ticket in-person and provide photo identification at the Tecumseh School Board business office (1301 E. Highland St, Tecumseh, OK 74873) during normal business hours (M-F 8am-5pm) to claim a prize. The winner will receive a phone call and an email about their Prize Claim, they must respond no later than five (5) business days after his/her notification. In the event the winner: (a) does not notify the Superintendent within thirty (30) days of the drawing; (b) is ruled ineligible for any reason; or (c) refuses the prize, the Athletic Department will select an alternate potential winner in their place at random from the remaining non-winning, eligible entries.
- 10. Odds. The odds of winning a prize depend on the number of Raffle Tickets purchased for the drawing.
- 11. <u>Judges</u>. The Raffle will be conducted and supervised by the Athletic Director, whose decisions are final. The Athletic Department reserve the right to modify these Official Rules at any time. The Athletic Department reserve the right, in its sole discretion, to cancel or suspend the Raffle should unauthorized human intervention or other causes corrupt the administration, security, fairness, integrity or proper operation of the Raffle.
- 12. Release of Liability. By entering into the Raffle, all entrants agree to:
 (a) be bound by these Official Rules; and (b) release the Athletic Director, The
 Athletic Department, Tecumseh Schools, and each of their respective

subsidiaries, advertisers, partners, affiliates, directors, officers, officials, agents, volunteers, and employees, from any and all liability with respect to any and all claims, injuries, damages, losses and liabilities that may occur, directly or indirectly, in whole or in part, from the participation in the Raffle, including any and all liability (including negligence) for property damages or personal injuries (including the consequences of such injuries, such as death) with respect to acceptance, possession, or use of the prize or from any travel or activity related to the receipt or use of any prize.

- 13. Publicity Release. Each winner, by accepting a prize, grants the Athletic Department and Tecumseh Schools, including the other Released Parties, full permission, except where legally prohibited, to use such as winner's name, address (city and state only), photograph, voice and/or other likeness, and prize information for advertising, trade and promotional purposes without further compensation and without notice, review or approval, in all media now known or hereafter discovered, worldwide and in perpetuity. Each winner shall execute all documents that the District may require to be signed in connection with this release.
- 14. **General Conditions**. Released Parties are not responsible for stolen, late, incomplete, illegible, inaccurate, misdirected, lost, misrouted, scrambled, damaged, delayed, undelivered, mutilated, postage-due or garbled entries, transmissions or e-mail; or for lost, interrupted or unavailable network, cable, satellite, server, Internet Service Provider (ISP), wireless network, website, app. or other connections including those through and/or by any website or app, availability or accessibility or miscommunications or failed computer, satellite, telephone, cable or wireless transmissions, lines, or technical failure or jumbled, scrambled, delayed, or misdirected transmissions or computer hardware or software malfunctions, failures or difficulties; any error, omission, interruption, defect or delay in transmission, processing, or communication; non-delivery; misdirected, blocked, or delayed e-mail notifications; printing, typographical or other errors appearing within these Official Rules, in any Raffle-related advertisements or other materials; or any other errors, problems or difficulties of any kind whether human, mechanical, electronic, network,

computer, telephone, mail, typographical, printing or otherwise relating to or in connection with the Raffle, including, without limitation, errors or difficulties which may occur in connection with the administration of the Raffle, the processing of entries, the announcement of the prize or in any Raffle-related materials, or the cancellation or postponement of any Tecumseh games, event or exhibition. Released Parties are also not responsible for any incorrect or inaccurate information, whether caused by website users, tampering, hacking, or by any equipment or programming associated with or utilized in the Raffle. Released Parties are not responsible for injury or damage to entrants' or to any other person's computer related to or resulting from participating in the Raffle or downloading materials from or use of the Tecumseh website. Persons who tamper with or abuse any aspect of the Raffle or attempt to undermine the legitimate operation of the Raffle by cheating, deception or other unfair playing practices, or intend to annoy, abuse, threaten or harass any other entrant or any representative of the Athletic Department/Tecumseh Schools and/or the Released parties or who are in violation of these Official Rules, as solely determined by the Athletic Department, will be disqualified and all associated entries will be void. Any attempt to deliberately damage the content or operation of the Raffle is unlawful and subject to legal action by the Athletic Department, and Tecumseh Schools. The Athletic Department shall have the sole right to disqualify any entrant for violation of these Official Rules or any applicable laws relating to the Raffle, and to resolve all disputes in its sole discretion. Released Parties (i) make no warranty, guaranty or representation of any kind concerning any prize (or any portion thereof); and (ii) disclaim any implied warranty. The Athletic Department's failure to enforce any term of these Official Rules shall not constitute a waiver of that provision.

The Athletic Department reserves the right, in its sole discretion, to cancel or suspend the Raffle (or any portion thereof) for any reason.
