Chris distributed FHUHS/ARSU Office Relocation post-bid project budget sheet and Contractor bid summary from three General Contractors; VMS, Russell, and Wright - review and discussion of background check of contractor employees, entrance into the building, and the interruption of school learning with the interior work and school being in session. Chris added that the exterior work would be completed by August 24th, and the interior work completed by October 15th with central office moving in November 1st.
