There are two areas of concern for the upcoming year, they are:

P.E. Instructional Time for the 6<sup>th</sup> grade.

We have made our reports to the state meeting this requirement. In the upcoming years our 6<sup>th</sup> grade students will need to increase their P>E> instructional time to the 225 minutes per week. This will need to happen either through the elementary schedule or building a new room for them at our middle/high school. They currently are incorporated in with our K-5 students who receive 160 minutes. All other classes meet this requirement.
