- 2. <u>Agenda:</u> Mike Fallis moved to accept the agenda and it was seconded by Liz MacKay. The motion passed.
- 3. <u>Minutes:</u> Mike Fallis moved to accept the minutes of the previous meeting, seconded by Liz MacKay. The motion passed.
- 4. Public Comment: None
- 5. Review of Policies to Warn:

The committee reviewed the five recommended policies (A20, A21, A22, A23, and A24) from the VSBA organization of policies.

A21: It was agreed to make some more revisions to Policy A21. The revisions are as follows: 1. Delete the words on Agenda Items from the fourth title <u>Public Comment on Agenda Items</u>. 2. Change #1 under the <u>Public Comment heading to The chair will ask for public comment at the appropriate time during the meeting</u>. 3. Delete the second sentence of #2 under <u>Public Comment</u>. 4. Add and/or use of a time constraint to the end of #2's first sentence under Public Comment. 5. Delete the entire last section titled <u>Public Input on items not on the agenda</u>.

A22: Policy A22 is ready to be warned.

A24: Policy A24 is ready to be warned.

Transfer Policy: The committee recommended some additional changes: 1. Change 2018-2019 to 2019-2020. 2. Add (beginning in 2019) to #8. 3. In #7 delete the word have.

6. Review of Policies:

B20: The committee agrees with this policy as it is written with one recommendation. That is to delete (the school district) in #1 of the Selection section.

B21: The committee agreed to not include this policy.

B22: Some people on the committee did not like the wording on this policy. Brooke agreed to rewrite this policy and it will be reviewed at the next meeting.

C20: The committee will wait to review this policy after input from the principals is received

C21: Brooke will review this policy with the school principals so that the committee will have more pertinent information before making any decisions.

7. Other:

Brooke shared with the committee that Emily Simmons (lawyer with the VT School Board Association) will have a policy manual ready for the committee to review within the next couple of weeks. Emily has read the existing policies of the district's schools. The manual will include a compilation of all the required policies.
