- F-34 Idling of Buses (Warn tonight)
- C-37 School Entrance Age (Warn tonight with noted corrections: eliminate entire second bulleted information; in third bullet eliminate (three (3) year old-wording to read: For admission into the Universal Preschool Program. Eliminate (where applicable and space is available).
- C-38 Extended School Year Policy (Warn Tonight)
- Remove Student Education Records from list, already adopted.
- C-39 Transition of Toddlers with Disabilities to Preschool (Table till 4/23/18)
- C-40 Transporting Students To and From Co-Curricular (Table to 4/23/18 with noted correction in fifth paragraph add a period after Parent/Guardian/Relative (add a . after relative). In the same paragraph place a period after children and before Parentheses in third sentence.
- D-34 Role of Religion in Schools- Religious Observances and Symbols Brooke pointed out to committee that our Attorneys suggested adopting this policy with no changes as we have already had one finding against us as a School District. Considerable discussion ensued. Liz pointed out that she believes this policy is not a policy and that it is unconstitutional and would not hold up. Brooke offered to have the Attorney come to address but pointed out that it would cost roughly \$1,500.00. There was also discussion about changing the wording throughout the document to read Parent/Guardian/Relative to read Parent/Guardian/or Other Designated Adult. M. Bache suggested adopting as the Board's Attorney recommended. Liz offered up some other research she has been doing; she will share this with committee members prior to the next meeting to see if they want to recommend another version of the policy, or if they want to withdraw the policy altogether.
