- d) *In the event the Board challenges any of the statements I have made, and it is determined that the child/children is/are not eligible to attend the District's schools, I may be obligated to pay the Board the tuition cost for all days of ineligible attendance in the District's schools. Tuition shall be based on actual cost per pupil, and shall include the cost of any additional educational programs and/or services required for the child(ren)'s education. _____ (Initial)*
