    - ii. Resignation Report Haynes reported high school/middle school custodian, Richard Barrett, has resigned to take a job with Grand Gateway.
  - b. Construction Manager Report Aaron Hight, Crossland Construction Company Project Manager, presented a Capital Improvements Construction/Progress Update. Hight reported a request for bids on the middle school demolition were going out on June 14, bids will be opened on June 28, demolition is scheduled to start on July 5, all cleaned up by August 12, and completed by August 2017.
  - c. Dana Garard, Opaa! Food Management Inc., Director Nutrition Services, Report Garard report on the ice cream at field day and the last day at the middle school and high school, 116,553 lunches, 58,058 breakfasts, 4,334 snacks, and 2,000 adult meals up 5%.
  - d. Elementary Principal's Report Elementary Principal Kevin Wade reported summer reading is going on, averaging 28 per day, and maintenance is going well.
  - e. Middle School Principal's Report Middle School Principal Jack Kelley was on vacation.
  - f. High School Principal's Report High School Principal Jim Buttram reported the schedule is made for next year, Danny and Bruce are doing a good job, they need a person to mow.
