McLoud Elementary Parental Involvement Policy

Annual Schoolwide Parent Orientation

Parents will be notified and encouraged to attend the orientation meeting by way of local newspaper, school website, school and city marquees, and district-wide robo calls.

A parent orientation will be held in August to introduce:

- Title I Schoolwide status and its implications for Elementary students
- Oklahoma Academic Standards as relative to curriculum and student proficiency
- Elementary developmentally appropriate curriculum
- DIBELS, Literacy First, STAR Reading and BEAR literacy assessments
- Response to Intervention
- Parents as teachers skill-based seminars to be held each semester
- Parent Teacher Organization officers and upcoming parent involvement opportunities such as book fair, Literacy Night, Mc Teacher Night, Box Tops for Education program, Principal's PRIDE, and end of the year celebrations
- Availability of student services such nutrition program, transportation, building security measures, special services, and federal programs
- Methods of school-home communication

McLoud Public Schools District-Wide Parental Involvement Policy

Mcloud Public Schools considers the education of each and every child to be a team effort. This team should consist of parents/guardians, classroom teachers, school administrators, and community members.  consistent with section 1118(d) of the ESEA.
- The school district will incorporate this district wide parental involvement policy into its LEA plan developed under section 1112 of the ESEA.
- In carrying out the Title I, Part A parental involvement requirements, to the extent practicable, the school district and its schools will provide full opportunities for the participation of parents with limited English proficiency, parents with disabilities, and parents of migratory children, including providing information and school reports required under section 1111 of the ESEA in an understandable and uniform format and, including alternative formats upon request, and, to the extent practicable, in a language parents understand.
- If the LEA plan for Title I, Part A, developed under section 1112 of the ESEA, is not satisfactory to the parents of participating children, the school district will submit any parent comments with the plan when the school district submits the plan to the State Department of Education.
- The school district will involve the parents of children served in Title I, Part A schools in decisions about how the 1 percent of Title I, Part A funds reserved for parental involvement is spent, and will ensure that not less than 95 percent of the one percent reserved goes directly to the schools. This will apply only to districts that receive \$500,000 or more in Part A funds.

• The school district will be governed by the following statutory definition of parental involvement, and expects that its Title I schools will carry out programs, activities and procedures in accordance with this definition:

Parental involvement means the participation of parents in regular, two-way, and meaningful communication involving student academic learning and other school activities, including ensuring:

- (A) That parents play an integral role in assisting their child's learning;
- (B) That parents are encouraged to be actively involved in their child's education at school;
- (C) That parents are full partners in their child's education and are included, as appropriate, in decision-making and on advisory committees to assist in the education of their child:
- (D) The carrying out of other activities, such as those described in section 1118 of the ESEA.

McLoud Public Schools may involve parents in the development of its district wide parental involvement plan under section 1112 of the ESEA by:

- Receive comments and input at Title I advisory committee meetings
- Review the initial plan and receive comments at community meetings
- Annually review plan and revise as necessary

McLoud Public Schools may take the following actions to involve parents in the process of school review and improvement under section 1116 of the ESEA

- Have parents serve on district-wide committees
- Report annually to all parents the results of state mandated assessments
- Conduct an annual public hearing on the McLoud Public School budget
- Provide an open forum for parental input at the monthly meetings of the McLoud Board of Education
- Receive input from parents at monthly meetings of the PTA
- Process an annual needs assessment from parents/guardians

McLoud Public Schools may provide the following necessary coordination, technical assistance, and other support to assist Title I, Part A schools in planning and implementing effective parental involvement activities to improve student academic achievement and school performance:

- Provide time and resources to conduct Parent-Teacher conferences each year
- Schedule and fund high quality professional development to educate staff concerning parental involvement
- Provide reasonable and necessary resources to allow all schools within the district to implement effective parental involvement programs
- Provide time and resources to conduct Open House each year

McLoud Public Schools may coordinate and integrate parental involvement strategies in Part A with parental involvement strategies under the following other programs:

- Literacy First
- Great Expectations

McLoud Public Schools may take the following actions to conduct, with the involvement of parents, an annual evaluation of the content and effectiveness of this parental involvement policy in improving the quality of its Title I, Part A schools. The evaluation will include identifying barriers to greater participation by parents in parental involvement activities (with particular attention to parents who are economically disadvantaged, are disabled, have limited English proficiency, have limited literacy, or are of any racial or ethnic minority background). McLoud Schools will use the findings of the evaluation about its parental involvement policy and activities to design strategies for more effective parental involvement, and to revise, if necessary (and with the involvement of parents) its parental involvement policies.

- Annual needs assessment will be sent home with all students
- Title I Coordinator will be responsible for coordinating and tabulating this instrument
- Title I advisory committee will have parents as members
- Results of this instrument will be shared at public meetings
- Input from parents will be taken at public meetings

McLoud Public Schools will build the schools' and parents' capacity for strong parental involvement, in order to ensure effective involvement of parents and to support a partnership among the school involved, parents, and the community to improve student academic achievement, through the following activities specifically described below:

 - 1. Sending an annual school report card home to all parents
 - 2. Having an open-door policy by all school administrators whereby parents can ask questions at any time
 - 3. Providing a school compact for each student participating in Title I, Part A
 - 4. Periodic newsletters and school activities calendar sent to all parents

McLoud Public Schools may, with the assistance of its schools, provide materials and training to help parents work with their children to improve their children's academic achievement, such as literacy training, and using technology, as appropriate, to foster parental involvement by:

- Offering technology training to parents when appropriate
- Providing newsletters and the latest scientific based research on topics of interest to parents such as technology and improving reading skills of students
- Provide periodic parent/teacher conferences to give certified staff the opportunity to assist parents in the academic progress of the student

McLoud Public Schools may, with the assistance of its schools and parents, educate its teachers, pupil services personnel, principals, and other staff, in how to reach out to, communicate with, and work with parents as equal partners, in the value and utility of contributions of parents, and in how to implement and coordinate parent programs and build ties between parents and schools by:

- Offering the latest research based Professional Development activities to all school personnel
- Communicate to school personnel either through staff meetings and/or newsletters the latest news and research concerning parental involvement as school administration becomes aware of or receives further training in this area

McLoud Public Schools may take the following actions to ensure that information related to the school and parent programs, meetings, and other activities, is sent to the parents of participating children in an understandable and uniform format, including alternative formats upon request, and, to the extent practicable, in a language the parents can understand:

- Upon request, a translator will be available to explain the information to parents in a language they can understand
- Upon request, an interpreter for the hearing impaired will be available to explain the information to parents in a way they can understand
- All information sent to the parents will be written in the simplest terms possible to ensure that a majority of parents can understand and apply the information
