PRIVILEGE OF THE FLOOR

Mr. Trusty – Why did this process take so long since we had a scheduled time? Secondly, how do we vote on children's discipline when we have displayed inappropriate ourselves?

Ms. Trusty – My appointment was at 9:00 p.m. This ridiculous that we are here this late. I've been waiting since April 30th for a response.

Ms. Matos – I am here ask the Board to dismiss the charges for criminal activity in the school. Students within our school district have not been supplied with proper intervention and with certain protections. Some of the students are undocumented and by having a criminal charge against them could cause deportation.

Ms. Jones - What are the interventions that you have in place? What is your protocol? If there were no interventions in place, then you can't go to criminal charges.

Mr. Whilby – Steven Berrios actions were egregious. Compared to the actions of adolescents it doesn't make any sense that you are legislatively lynching our children. The fight has been sensationalized. We believe in second chances – we believe that these kids made a mistake. You aren't doing us any favors by criminalizing our kids. The District hasn't done what it's supposed to do. The parents tell me home schooling hasn't been set up. There's no student handbook. I want to commend Donovan Rodriques for trying to show the rest of you how to be effective Board members. Donovan exemplifies behavior that would turn this train wreck around.

Mr. Kravitz – I apologize for the late evening as well as not keeping with the schedule The Board and I felt it would be best to hear everybody's comments and take it all into account. There is no decision tonight. We will have another meeting to determine what the consequences will be. But first we need to hear from every parent. As far as interventions, some students have been given counseling and have gone to the school counselors. We can't force them to go to counseling.
