I. Monica Dean called the meeting to order at 12:00 PM and read the following:

II. Board Action

Consideration of a motion to accept the agenda dated May
 16, 2017. Motion made by Patrick Howland and seconded by
 Cindy Baker. Passed by 4 votes of Yes.

Board President Monica Dean read the following:

PROPOSITION 1 - GENERAL BUDGET

SHALL THE following be adopted to wit: RESOLVED that the Board of Education of the Andover Central School District be authorized to expend the sums set forth in the proposed 2017 - 2018 budget in the amount of \$9,311,400 and to levy the necessary taxes.

PROPOSITION 2 – BUS PURCHASE

BE IT RESOLVED, THAT The Board of Education of the Andover Central School District is authorized to expend an amount not to exceed \$122,000 from the District's existing capital reserve fund known as the 2015 Bus Purchase Reserve Fund for the purchase of one (1) 65-passenger school bus and with the result that such expenditure from the Bus Purchase Reserve shall have no impact on the tax levy of the District for the 2017 – 2018 school year.

PROPOSITION 3 - BUS PURCHASE RESERVE FUND

BE IT RESOLVED, THAT THE Board of Education of the Andover Central School District is authorized to establish a reserve fund pursuant to Education Law Section 3651, to be known as the 2017 Bus Purchase Reserve Fund for the purchase of school buses, vehicles and equipment, and costs incidental thereto, in an amount not to exceed \$1,200,000 plus interest and for a probable term of 10 years, but the fund shall continue in existence until the voters shall determine that the original purpose for which the fund was established is no longer desirable and that the fund should be liquidated. The sources from which funds will be obtained for such fund are: (a) from unappropriated fund balance this year and in each fiscal year thereafter in such amount as the Board of Education may designate from the unappropriated fund balance remaining in the general fund at the end of each fiscal year; (b) amounts of budgetary appropriations from time to time, and New York State Aid received on bus purchases and made available by the Board of Education from time to time.

PROPOSITION 4 – CAPITAL IMPROVEMENTS PROJECT

BE IT RESOLVED, THAT THE Board of Education of the Andover Central School District is authorized to undertake a capital improvements project consisting of reconstruction of the school buildings and facilities, to include the K-12 school building and the bus garage, various site improvements and the acquisition of certain original furnishings, equipment, and apparatus and other incidental improvements required in connection therewith for such construction and school use, all at an estimated maximum aggregate cost of \$6,790,000; and to appropriate and expend from the existing capital reserve fund \$500,000 for such costs, or so much thereafter as may be necessary, shall be raised by the levy of a tax to be collected in annual installments, with such tax to be offset by state aid available thereof; and in anticipation of such tax, debt obligations of the school district as may be necessary not to exceed \$6,290,000 shall be issued.
