Board President Monica Dean read the following:

#### **PROPOSITION 1 - GENERAL BUDGET**

SHALL THE following be adopted to wit: RESOLVED that the Board of Education of the Andover Central School District be authorized to expend the sums set forth in the proposed 2016 - 2017 budget in the amount of \$9,182,475 and to levy the necessary taxes.

#### PROPOSITION 2 – CAPITAL RESERVE FUND

BE IT RESOLVED, THAT The Board of Education of the Andover Central School District is authorized to establish a reserve fund pursuant to Education Law § 3651 (1), to be known as the 2016 Capital Reserve Fund for the construction, repair, and reconstruction of capital improvements and the acquisition of equipment in an amount not to exceed \$2,000,000 for a probable term of 10 years. The source from which funds will be obtained can include any or all of the following: unappropriated fund balances from the general fund as determined by the Board of Education; State Aid related to expenditures from the capital reserve fund; interest income related to investment of monies in the fund; and any other additional monies thereafter authorized by the voters of the District.

### **PROPOSITION 3 – BUS PURCHASE**

BE IT RESOLVED, THAT THE Board of Education of the Andover Central School District is authorized to expend an amount not to exceed \$121,000 from the District's existing capital reserve fund known as the 2015 Bus Purchase Reserve Fund for the purchase of one (1) 65-passenger school bus and with the result that such expenditure from the Bus Purchase Reserve shall have no impact on the tax levy of the District for the 2016 – 2017 school year.
