13. Consideration of a motion to adopt a Capital Reserve 2016 proposition to establish a capital reserve fund under the provisions of Education law §3651(1) in an amount not to exceed \$2,000,000. The purpose of the fund is for construction, repair, and reconstruction of capital improvements and the acquisition of equipment. The probable term shall be ten years. The source from which funds will be obtained can include any or all of the following: unappropriated fund balances from the general fund as determined by the Board of Education; State Aid related to expenditures from the capital reserve fund; interest income related to investment of monies in the fund; and any other additional monies thereafter authorized by the voters of the District.
