# RENEWAL OF DISTRICT-WIDE ANTI-VIRUS TECHNOLOGY

After negotiating for several weeks with the publisher and distributor of our district-wide anti-virus technology, Roger Lange, Technology Supervisor, was offered an incentive to place an order before the end of March, since is the end of their fiscal year.

Mr. Lange said that there will be a significant reduction in the number of licenses purchased, since he believes anti-virus protection is not necessary for Macintosh computers. Based on the count of Windows computers the district has, the vendor has offered that if we commit to a three-year renewal, they will add a fourth year at no extra charge. The total cost for the four-year contract would be \$12,000.00, payable in four yearly installments of \$3,000.00 each. This is a very substantial savings compared to our previous annual payment, which was \$13,447.50 for just one year.

In order to take advantage of this incentive, Mr. Lange is asking for board approval to place this order before the end of March.

Mr. Lind questioned if Mr. Lange would get written verification of upgrades to be included in the price.

Mr. Lange said he could do that.

# **ADDITIONAL COMMITTEE REPORTS**

Mr. Crutchfield said that the Policy Committee has finished rewriting several policies and will be presenting them for first reading approval at the April meeting. They are continuing to go through the policy manual. Mr. Crutchfield thanked Mr. Robertson for moving things along.

Mrs. Smith said the Academics Committee will meet next Tuesday at 6:00 PM. Mrs. Finn will replace Mr. Wilson on the committee.

Mr. Wilson met with Jeff Adams and Dwight Needham to discuss modulars. He said it might be possible that the State will allow us to separate the modulars from the building and store on site, which will give us the time needed to get rid of them. He also said the athletic department could use extra sheds to store equipment. Two of the modulars could be converted and used at different locations.

# **BUDGET WORKSHOP #2 – Pay-to-Play**

Mr. Robertson reviewed an athletic pay-to-play summary of school districts in the area. It was noted that Chambersburg was not included on the list, but Mr. Robertson said they don't charge to play. Mr. McLaughlin, Athletic Director, was asked how many students are involved in sports. He said there are 703 students with physicals, which includes grades 7-12. He said 191 of these students play two sports and 61 play three sports. He reminded the board that these 703 students do not account for cuts and students who end up not participating at some point during the season.

Mr. Lind asked administration for information on extra-curricular clubs and how many students participate in each.

Ms. Dean reviewed budgetary revisions as follows:

- 1. It was discussed that we add the additional Basic Education Subsidy projected for the 2010/2011 year, to the budgetary contingency so that we may spend it if we receive it but, if we do not receive the revenue, we have covered the deficit as part of the budgeting process.
- 2. The above numbers included \$91,119 or 13.1% reductions made at the school level, in controllable expenses and consumables, as requested.

- 1. Reductions include \$269,075 in medical expense, which will be taken from the Medical Fund Balance. We must use caution when utilizing our fund balance.
- 2. \$390,000 in Retirement Reserve. The budget allows for the 8.22% requirement but does not adequately prepare the district for future cost increases.

# BUDGET WORKSHOP #2 - Pay-to-Play (Cont'd)

- 3. Transfers to the Capital Reserve Fund for building maintenance is reduced \$100,000 which does not allow routine and necessary maintenance to be performed without utilizing the fund balance.
- 4. The Probation Officer position paid through Franklin County has been eliminated for a savings of \$15,279.
- 5. Two teaching positions have been eliminated for a total net savings of \$153,009. This savings can only be realized if these individuals retire and we have no official letters at the current time.
- 6. This budget contains no salary increase for the professional or support staff. This is significant as we will need to be prepared for future increases.
- 7. Our adjusted index is 3.7%, allowing for a maximum millage increase of 3.056 or \$723,911.

Mr. McLaughlin said there could be a savings in the realignment of the Middle School cheerleading, basketball, and football teams. He said he is not recommending any of this be done, it was just for information. He said the cheerleaders only cheer at a few home games and participation doesn't appear to make much difference once they reach high school. He said there are extremely low numbers in 9th grade boys and girls basketball. These students could be playing on JV or varsity teams. He said this would save approximately \$8,500. Concerning 9th grade football, these students could be playing on JV and varsity teams. This would save the district approximately \$11,400. He said by reducing coaches attending clinics every year (would attend every three years) would save approximately \$18,000. He reminded the board that gymnastics cost the district \$20,000+.

Mr. Lemley questioned who gets in free when attending a game. Mr. McLaughlin said that fall athletes in grades 7-12, parents of athletes, school district employees and their spouses; and retired district employees. Football players, cheerleaders, members of the field band and outdoor guard get two free admissions for parents who attend each home football game. Senior citizens get in for a reduced rate.

Mr. Robertson reminded board members that only \$168,288 has been reduced in retirements. There is still \$370,000 to go. He said if the position is critical, you have to fill. He said that talking to administration, the worst case scenario would be significant cuts, which include driver education, elementary Spanish, and programs that are not required by Chapter 4 regulations, all of which the State would have to approve to be eliminated.

Mr. Lind questioned if PSSA tests arrived. Mr. Williams said they had. Mrs. Heefner asked how many students were excused from taking 4Sights. Mr. Williams replied there was a significant number. The students said that was a valuable incentive for them.
