Katharine Ayer moved to accept a Memorandum of Understanding with Winthrop Public Schools for Special Education Director, pending clarification the contracted salary amount does not exceed Fayette School Department's budgeted amount for this position. Jennifer Bero seconded and the motion carried 5-0.

- 7. Comments from the Public: Selectman Jon Beekman stated he would expect the School Committee to stand by their acceptance, at the June School Committee meeting, of the resignation of the Special Education Director.

He was trying to get a sense of their expectations and what parameters he can work within. The Committee did not want the bookkeepers office space changed as it provides her the necessary privacy needed to perform her job. They are concerned about the special education classroom being so close to the office and would prefer that it be moved. Ultimately, it is up to Superintendent Cormier as to how this is done.

Superintendent Cormier spoke about the staffing structure for the 2014-2015 school year. He is meeting with staff tomorrow to get a sense of what they want. He is also looking at the current budget. He will come back to the School Committee with his recommendation and corresponding budget increase.
