# Northern Tier Career Center REGULAR MEETING of the JOINT OPERATING COMMITTEE Thursday, December 13, 2018, at 6:30 PM NTCC Multi-Purpose Room

The Northern Tier Career Center's Joint Operating Committee held a meeting for reorganization and general purposes, on December 13, 2018 at 6:30 PM, in the Multi-Purpose Room, at the Northern Tier Career Center, Towanda, Pennsylvania.

President Gene Anne Woodruff called the meeting to order at 6:35 PM followed by the Pledge of Allegiance. The following board members responded to roll call: Gene Anne Woodruff (Wyalusing), Howard Rought, Jr. (NEB), Hal Stockdill (Sullivan), Evelyn Sherburne (Towanda), and Ron Cole (Sayre). Also present were Jason Bottiglieri, Superintendent of Record; Gary Martell, Director; Michele Welles, Business Manager; Margaret Johnson, PN Coordinator; and Jennifer Farley, Administrator of Education Services. Gayle Burkett (Athens) and John Morgan (Troy) both notified that they would not be in attendance. Neal Palmer (Canton) was also absent.

organizational meeting: A nomination was made by Howard Rought, Jr. (NEB) and seconded by Hal Stockdill (Sullivan) to appoint Evelyn Sherburne (Towanda) temporary Chairperson to conduct the organizational meeting. Howard Rought, Jr. (NEB) made and Hal Stockdill (Sullivan) seconded a motion to accept Evelyn as temporary chairperson. On roll call vote, all five members voted in favor. Evelyn asked for nominations for Chairperson. Howard Rought, Jr. (NEB) nominated Gene Anne Woodruff as Chairperson. Hal Stockdill (Sullivan) made a motion to close the nominations. Hal Stockdill (Sullivan) made a motion to accept Gene Anne Woodruff (Wyalusing) as Chairperson and Ron Cole (Sayre) seconded the motion. The motion to elect Gene Anne Woodruff (Wyalusing), Chairperson carried by unanimous approval. Howard Rought, Jr. (NEB) nominated Gayle Burkett (Athens) as Vice Chairperson and Ron Cole (Sayre) made a motion to close the nominations. Hal Stockdill (Sullivan) made and Ron Cole (Sayre) seconded a motion to approve Gayle Burkett (Athens) as Vice Chairperson. All members voted in favor. Ron Cole (Sayre) made a motion to name Michele Welles as Deputy Board Secretary in the absence of the Board Secretary. Howard Rought, Jr. (NEB) seconded the motion. On roll call vote, all members voted in favor. Chairperson Woodruff announced at 6:40 PM that the organizational meeting was adjourned and the regular meeting would begin.

**PRESENTATION**: Mr. Martell shared data on the audit review. The tiny house covers two fiscal years, and the revenue from the scrap cars needed to be spent by June 30, 2018. The audit showed \$894 left and it is being requested not to return this to the home schools. Michele Welles shared information on the budget line transfers that we are being asked by the auditors to conduct.

VISITORS: There were no visitors.

**MINUTES**: Howard Rought, Jr. (NEB) made and Evelyn Sherburne (Towanda) seconded Approval of the October 18, 2018 meeting minutes. The motion carried unanimously on roll call vote.

**REPORTS**: Mr. Martell gave his reports which are attached. Current Enrollment of the Practical Nursing Program changed after this printing to be 29.

Superintendent of Record, Dr. Jason Bottiglieri, reported that the superintendents will be at the Center on Friday for three meetings. The first meeting will be with the Progress Authority and Northern Tier Regional Planning and Development followed by the superintendents' meeting and then concluding with

a representative on Career Readiness. He has requested that the districts have the career coaches hired as additional personnel with the grant that has been acquired.

**FINANCIAL REPORTS:** Howard Rought, Jr. (NEB) made and Hal Stockdill (Sullivan) seconded a motion to approve the Summary of Bills, October 13, 2018 to November 10, 2018, Financial Report as of October 31, 2018, the Student Activity Financial Report as of October 31, 2018, Summary of Bills, November 11, 2018 to December 8, 2018, Financial Report for November 30, 2018, and the Student Center Report as of November 30, 2018. Roll call vote indicated unanimous approval.

**CORRESPONDENCE**: There was no correspondence.

**DONATIONS**: Donations were received from Precision Pipeline in Covington, Pennsylvania and a 2012 Ford Focus was donated as part of the Ford Asset Program for transportation shops.

**BUSINESS**: A motion was made by Ron Cole (Sayre) and seconded by Howard Rought, Jr. (NEB) to move the \$894.23 remaining balance from the 2017-2018 budget to the Reserve. On roll call vote, all members voted in favor.

Ron Cole (Sayre) made and Howard Rought, Jr. (NEB) seconded a motion to approve the 2017-2018 Budge Line Transfers. All members voted in favor on roll call vote.

Howard Rought (NEB) made and Hal Stockdill (Sullivan) seconded a motion to approve the Sweet, Stevens, Katz, Williams Legal Agreement. Roll call vote showed unanimous approval.
