I. PROGRAM ACTIVITIES

- A. Semester II began January 2, 2018
 - i. Students completed two weeks of classroom learning of Medical-Surgical Nursing and Medication Administration
 - ii. Clinical sites: Robert Packer Hospital (2 groups)
 Guthrie Towanda Memorial Hospital (1 group)

Clinical starts at 6:30 AM. Students look up information about their client and obtain report from nursing staff. They complete total care of the client: nursing care, assessments, vital signs, and some medication administration. On alternate days, students go to other areas to observe and learn such as dialysis, gastrointestinal procedures, respiratory therapy, operating room, Intensive care unit, and different areas of the clinic.

- C. NCLEX pass rate: 88.9% (90.5% for Class 2016)
- D. The Prep Course starts February 8, 2018
 - i. Offered to any NTCC senior student interested in attending our Practical Nursing Program after graduation. The Prep Course prepares the senior students for the ATI TEAS test which is the pre-entrance exam for the Practical Nursing Program. The prep course is every Thursday (February 8th to March 15th) including the test date.
- E. The next Pre-Entrance Exam is scheduled for February 14, 2018
