The proposed improvements will start this summer and all areas will be completed by the beginning of the 2011-2012 school year.

#### **Itasca City Council February Meeting**

The Itasca City Council met in a regular session on Tuesday, February 16, 2010 in the Council Chambers, 136 N. Hill St., Itasca, Texas. Mayor Matthew Fehnel called the meeting to order. Council members present were James Bouldin, Susie Davis, Denis Heyse and John Laird. Also present were City Administrator Mark Gropp and City Attorney Stephanie Johnson. Council Member Doug Farquhar were absent.

Motions were made and passed to approve the minutes of the January 19, 2010 meeting and to approve the payment of bills. Monthly department and committee reports were given by Chief Randy Kline (Fire Department), Chief John Griscavage (Police), Wayne Upchurch (Water/Sewer Operations), Chris Barnes (Planning and Zoning, Office of Code Enforcement and Building Standards Commission). The Council voted to re-scheduled a meeting for Building Standards Commission to Wednesday, February 17, 2010.

A report was received from City Administrator Mark Gropp regarding the evaluation of proposals from engineering firms in connection with the Engineering Request for Proposals Process relating to the Texas Department of Rural affairs CDBG 2010 Grant for wastewater improvements. Mr. Gropp reported the scoring committee met and had scored the proposals using the Texas Department of Rural Affairs scoring criteria. Three proposals were received from Oller Engineering Inc., Beach Sulak Partners, and Eprotec/Hibbs and Todd. The City Administrator's recommendation in connection with the Engineering Request for Proposals Process relating to the Texas Department of Rural Affairs CDBG 2010 Grant for wastewater improvements was considered. Based on the scoring the City Administrator Mark Gropp recommended the city contract with Oller Engineering, Inc. and the Council agreed.

The agenda item to consider and possibly take action on the award of a Letter of Agreement for Professional Engineering Services relating to the Texas Department of Rural Affairs CDBG 2010 Grant for wastewater improvements was discussed. A motion was made and passed to approve authorizing the City Administrator to negotiate the price and sign the Letter of Agreement for Professional Engineering Services with Oller Engineering, Inc.

Mayor Matthew Fehnel opened the meeting at 6:16 p.m. to hold a public hearing for Rio Motors located at 700 S. Hill Street, more specially known as legal description-Sunset Block 2 Lot 14-16, for a Chapter 11 Junk Vehicle Ordinance violation to determine whether the vehicles at that location should be abated in accordance with the Junked Vehicle Ordinance outlined in Chapter 11 of the City of Itasca Code of Ordinances. Larry Shrum presented information pertaining to his business located at 700 S. Hill Street, which included violation letters, Chapter 11 Junked Vehicles Ordinance, building permit applications from 2005 to 2007, information on their temporary tags, and provided a copy of his Independent Motor Vehicle Dealer license. The Mayor asked if there was any other information pertaining to the public hearing. Mr. Shrum informed the Council that he had no further information. The public hearing was closed at 6:26 p.m.

The Council discussed what action should be taken as a result of the public hearing in regards to whether the vehicles located at 700 S. Hill Street, more specially known as legal description-Sunset Block 2 Lot 14-16, should be abated in accordance with the Junked Vehicle Ordinance outlined in Chapter 11 of the City of Itasca Code of Ordinances. The Mayor and City Administrator read the August 8, 2005 City Council Meeting minutes which stated the business can not be a dismantling place, all vehicles within that property must be running and for sale. They also reviewed the September 19, 2005 minutes which stated the Council agreed that they would not tolerate the property becoming a nuisance and looking like a junkyard or wrecking yard in anyway. Mayor expressed that Mr. Shrum's business is not in compliance with minutes approved in 2005 and current City of Itasca Code of Ordinances. City Administrator stated that the car lots license is not the proper license to have for non-running vehicles or more specific junk vehicles. A motion to declare the business in violation of the Junk Vehicle Ordinance and that the said owner has 30 days to abate was made and passed by the council.

City Administrator Mark Gropp stated he would have all information from Engineering Firm at March 15, 2010 meeting. The meeting adjourned at 6:35 p.m.

The Itasca City Council met in a regular session on March 15, 2010 in the Council Chambers. Mayor Matthew Fehnel called the meeting to order at 6:02 PM. Present were Council members James Bouldin, Susie Davis, Denis Heyse, Doug Farquhar, and John Laird.

Motions were made and passed to approve the minutes of the February 2010 meeting and to approve the payment of bills. Monthly department and committee reports were given by Officer Ted Walton (Police), Mayor Matt Fehnel (Water/Sewer Operations), Chris Barnes (Planning and Zoning, Office of Code Enforcement and Building Standards Commission) and Randy Kline (Fire) who formally gave his resignation effective immediately. The Council and Administrator thanked him for his time and service.

#### Mrs. Brenda Swilley



The City Administrator updated the City Council on the letter of agreement between the City of Itasca and Oller Engineering Inc, for Professional Engineering Services relating to the Texas Department of Rural Affairs CDBG 2010 grant for wastewater improvements, The City Administrator stated the contract is currently in Gandolf's office awaiting time tables and signatures, once completed the contract will be given to the City Attorney for review. An update from City Administrator regarding city street repairs was presented to the Council. The City Administrator discussed current streets being corrected and the process of laying the asphalt which would eliminate weather damage. The City Administrator addressed the Council to discuss and consider possible improvements of city streets.


The City Administrator explained road projects he would like to start next year which included asphalting south College St where previous sewer work had been done, and the connection of Grayson to Spurgeon and Milford Rd. The City Administrator explained how all these projects would be completed with a top coat and sealant to prevent from weather damage.

City Administrator explained the budget and reviewed areas which were over budget; he explained with the purchase of new police cars and equipment each police officer would be assigned a vehicle which they would be responsible for, and the two remaining older vehicles would be used for the step program. The budget was approved.

### Remember When ... "Train Nostalgia"

I wonder how many of you miss the old time trains as much I do. I loved the mournful sound of the steam whistle. It raised goose bumps when it came through the Chambers Creek bottom, when we were on a fishing trip there, especially at night. This one was the old IG&N in that area. I have a VCR tape that plays all the sounds of the old trains. Remember the Chuff-Chuff-



Chuff that started off real slow then became faster as the train picked up speed

and then the sound of the clacking of the wheels on the rail joints. A person has to hear it to really appreciate the nostalgia.

Then there was the caboose. It was the command center of the train. It was red with a raised part on top so the engineer and the conductor could see far down the track. Also there was a small "porch" on back with a decorative railing. Today there are no cabooses on the trains since they have such modern communication and there is no train mail delivery, they are no longer needed. It sure looks strange now when a train passes and there is no caboose, just the end of a box car or coal car.

It seems that the main product hauled now is coal from Montana and Wyoming, to fuel the electric generators. When we see all the coal trains coming through makes one wonder what will happen when excessive global population uses up all of our natural resources such as coal, gas, and timber. I have no doubt that this will happen, then we will be in the cold and the dark, and that will be the demise of our planet as we know it. We talk about global warming, but our biggest threat is or will be excessive population. You can put just so many cows in a pasture.

Itasca owes its existence to the MK&T or "Katy" railroad as it is usually called. When the Katy came through around 1880 towns sprang up all along the tracks. The existing towns that were missed withered away when the railroads were built. They dug pits for the extra dirt for the right of way or roadbeds. Those pits then filled with water furnishing fishing holes. One I remember is south of Hillsboro. We called it the "Ballast Pits." It can still be seen on I-35 just before coming to the Willie Nelson Road. The Katy furnished a living for several of my relatives. My grandfather R.C. Curlee was section foreman out of Hillsboro for 35 years. Two uncles, a brother-in-law and a nephew all worked for the Katy railroad.

I wonder how many Hillsboro people remember the old two story telegraph station just south of town. It was called, "HighLow," and Mr. Nowlin and Mr. Sly worked there along with one of my uncles. I am sure many remember back during the 1930's and the great depression when so many of our men rode the trains to all parts of the country looking for work. I can see them now on top of the boxcars or looking out of the open doors to the cars. Then there were the hobos, but that is another railroad story.

Years ago up until about 1949 Highway 81 from Fort Worth to Waco came through the middle of Itasca. It turned west at the light, crossed the railroad tracks, and then turned back south in front of the Westside Garage, then went by the Itasca Cemetery and south to Hillsboro and beyond. About a mile south of Itasca where the highway paralleled the railroad there was a creek that ran under the railroad and the highway bridge. During extreme rain, the water got over the highway bridge and traffic had to wait for the water to go down before crossing the bridge. I heard Ernest Whitfield, (who lived nearby) tell of an incident once when this happened. There was a Greyhound bus stopped and the people were out looking at the water, when a "sissy" looking guy with an English accent exclaimed "Wheah" did it rain? (meaning where)

It was here about 200 feet from the railroad that Tom and Aunt Rose Whitfield built their home. I guess they built it there because they did not want a muddy road from the house to the highway, which was just across the tracks. There was something funny about this location also. The cattle pasture was along the railroad, and when the train came through, the cattle ran along with the train as though they were playing a game. It was funny to see the cows running along with udders flopping from side to side. There were other things connected with the trains such as when the depot agent handed the conductor instruction on a wire contraption with a handle. Also those of us who sold milk or cream, put the cans on the depot platform to be picked up. There were many bales of cotton loaded from the long platform, and the corn and oat crops were also hauled by train. These are some of the fond memories that we who are older remember with fondness when we hear an old train whistle blow.
