
and it was all Red from that point on.

Heat and Cars: Look Before You Leave

It's hard to imagine having to warn parents or caregivers about leaving children alone in cars, especially during the heat of the summer. But many caring and responsible people can forget the silent or sleeping child in the backseat. Others do not realize the risks involved in the backseat. Others do not realize the risks involved in leaving their children in the car and what begins as a quick errand can turn to tragedy in a matter of minutes.

If children are trapped inside cars, especially during seriously hot weather, it can result in heat exhaustion or heat stroke, also known as hyperthermia, can cause shock, seizures, irregular heartbeat, heart attack, and damage to the brain, liver, and kidneys.

HOW TO PREVENT TRAGEDY

- **Never leave your car keys where children can get them.
- **Keep car doors and trunks locked at all times, even in the garage or driveway.
- **Teach children not to play in or around cars.
- **Never leave your child unattended in a car, even if the windows are down and a windshield shade is in place or even just to run a quick errand.
- **Make sure all children leave the vehicle when you reach your destination.
- **Don't overlook sleeping infants!
- **Make sure that the seat belt and seat surface are not too hot before buckling up your child.
- **When you and your children exit the car, place a windshield shade in front and back windows to help cut down on the heat.
- **Make sure that kids' arms, legs, fingers, and toes are safely inside before closing doors.
- **Keep the rear fold-down seats closed to prevent kids from getting into the trunk from inside the car.
- **Contact your auto dealership about getting your vehicle retrofitted with a trunk release mechanism.
- **Be wary of child-resistant locks—make sure they function.
- **If your child does get locked inside a car, get him or her out as soon a possible. If you can't get him or her out yourself, call 911 or your local emergency number immediately.

Itasca City Council May Meeting

The Itasca City Council met in a regular session on Monday, May 24, 2010 in the Council Chambers, 136 N. Hill St., Itasca, Texas. Mayor Matthew Fehnel called the meeting to order at 6:04 p.m. All council members were present (Mayor Pro-Tem James Bouldin, Susie Davis, Denis Heyse, Doug Farquhar and John Laird. Also present were City Administrator Mark Gropp and City Attorney Stephanie Johnson.

Motions were made and passed to accept the minutes from the April 19, 2010 meeting and to approve the payment of bills. Monthly Department and Committee reports were given.

IV Fire Department – Copy of report was distributed for review, Itasca Police report by Chief John Griscavage, Water/Sewer Operations report by Wayne Upchurch, and the Planning and Zoning Committee minutes, the Office of Code Enforcement report and the Building Standard Commission minutes were all presented by Mayor Matthew Fehnel.

David Bane representing TXU Energy addressed the Council for a discussion to consider contract renewal rates for the supply of electricity for the City of Itasca. The contract options of term in months for renewal rates were reviewed. A motion was passed to accept the two years (24 months) contract plan rate.

The tabled Policy and Procedures for the Police Department was presented by City Administrator from the March 2010 meeting. The City Attorney was unable to completely go thru the policy before the meeting but did discuss with the Council recommended changes to sections of the policy that the City Attorney had already reviewed. The City Attorney was instructed by the Council to make the changes that she recommends to the policy. The Police Chief answered questions from council members and will get with the City Attorney on some items. The policy and procedures will be revisited again at the next meeting.

The City Attorney addressed the Council to discuss and consider amendments of Policy and Procedures regarding Vehicle Operator Standards. The City Attorney explained and proposed changes to amend Section 8.05 Accident Reporting to include accidents be reported no later than twenty-for (24) hours after the accident and adding Section 8.06 Vehicle Operator Standards to the Personnel Policies and Procedures Manuel.

Recommended amendments for FY 2009-2010 Operating Budgets were reviewed and passed. The Proposed FY 2010-2011 Operating Budgets were reviewed. The City Administrator explained that the income item for Ad Valorem Taxes increased because property value went up 11% in Itasca by the Appraisal District. The expense item for street major improvements is \$100,000 to repair streets. The Council agreed to present the proposed operating budgets at the next regular meeting for approval.

The Council voted to set June 21, 2010 as a public hearing time on the proposed FY 2010-2011 Operating Budget. During the open for general Mayor, Council and City Administrator discussion and reports Denis Heyse asked about the status of putting up school zone signs on Files Street and was told the state has not gotten back with the city. The meeting adjourned at 7:11 p.m.

Instruction for Saliva DNA Collection

Itasca PD and IISD students joined in sponsoring a Child ID program in May. Police Chief Griscavage urges parents that did not bring their children to collect DNA samples on their own and store them away. In Issue #23, we ran an article on collecting a clean hair and blood sample. This article will explain the process and instructions for collecting a clean saliva sample.

Use a clean Q-tip swab, being careful not to touch the swab or allowing the swab tip to be exposed to any surface or object.

Rub the swab inside the child's mouth, against the cheek area, gently but firmly for approximately 10 seconds.

Allow the sample to air dry for at least 2 hours. Place the dried swab in a clean envelope and seal with tape. Do not lick the envelope!

Hopefully, you will never need these DNA samples, but it is better to have them and never use them, than to need them and not have them.

Guest present were Dr. Steve Johnson, Philip Thomas, Megan Goff, Barbara Petrash, Mary Maddox, Devin Corbitt, Trey Bates and Bobby Campbell.

President Bason welcomed all visitors to the meeting. Rickie Harris presented certificates to students that participated in state events for CX debate, journalism and track.

Motions were passed to accept the results of the Itasca ISD Bond election (For: 172 - Against: 121 - Total votes cast: 293), to approve the board meeting minutes from April 12, 2010 Regular Meeting, April 12, 2010 Workshop and April 19, 2010 Special Called Meeting, and to approve the district financial report for April.

Motions were passed to approve the 6^{th} 2009-2010 budget amendment, to approve a resolution expressing official intent to reimburse costs of the school expansion project in the amount of \$1,000,000 and to approve the 2010-11 salary schedule.

Superintendent Pittman went over the planned staff development calendar. He reported on the facility improvement progress. The demolition of the old junior school and cafeteria expansion are scheduled to take place this summer. Sealed bids for the construction manager at-risk will be opened on June 10, 2010 at 2:00 p.m. He informed the board the district had sent in a corrective action plan for the Residential Facilities Tracker compliance to TEA.

The board entered executive session at 7:41 p.m. and reconvened into open session at 7:56 p.m. The meeting adjourned at 7:57 p.m.

Hill County Citizens view County Animal Control as a Priority

County animal control programs are not foreign to many living in our area of central Texas. If fact, over 2.2 million people living in the counties of Bastrop, Bell, Brazos, Burnet, Caldwell, Coryell, Fayette, Hays, Lampasas, Llano, McClennan (through Waco for rabies control), Travis, Washington (through Brenham for rabies control), and Williamson have some level of animal control for their citizens (interestingly, six of these counties are equal to or smaller than the population of Hill County). Why does Hill County remain without an animal control program? It's simple, animal control has yet to be determined a "priority" by our elected officials even with our ever worsening pet overpopulation where dangerous feral dog packs roam uncontrolled, unwanted dogs and cats breed at will, and criminal abuse and "dumping" is common-place—all stemming from one common source—irresponsible individuals. In a democracy, citizens are at the top of the organizational structure. Elected officials of the aforementioned counties have viewed animal control as a core service expected by their tax paying constituents. The safety of residents is given top priority. To enrich the community we call home, we in Hill County can do the same.

Pet overpopulation can simply be corrected with the placement of three "proactive" programs—Education, Low Cost Pet Sterilization, and Legislation (enforcement of animal control laws). As a group of citizens, Paw Pals has taken serious initiatives with the formation of two of three necessary proactive programs—Education and Low Cost Pet Sterilization. The remaining program, proactive enforcement of animal control laws, remains to be improved in Hill County. Proactively enforcing existing State of Texas animal control laws in our county has been repressed because of the absence of a county-level animal shelter. In other words, no place exists for citizens to surrender unwanted pets or to place free-roaming pets—so, we create an environment in the very place we call home where dog and cats simple proliferate at their natural exponential rate. Ignorance driven by a sense of desperation leads irresponsible persons with unwanted pets to either dump them or abandon them, leaving the law-biding and responsible citizens to pick up the pieces.

The following are but two examples how "proactive" enforcement of animal control laws can encourage responsible pet ownership. Hill County has some 12,204 households where over half, on average, own two dogs and/or cats (based on HSUS formula). Therefore, some 28,000 dogs and cats live within Hill County's households (this figure does include our abundant "stray" pet population). It is estimated that from 50-70% of dogs and cats are not current with the rabies virus vaccinations (nearly 100% of "strays" are not vaccinated). This means that up to 19,000 pets living with families in Hill County are not protected from the deadly rabies virus in Hill County—an area already quarantined by Texas Department of Health Services for rabies. If the pets are unvaccinated, then their owners are also unprotected in the event of exposure. Does it make sense to expose our children to such a dangerous environment? It is common place in Hill County to "dump" dogs or cats near schools with the criminal-mannered notion that school children will take home the unwanted dogs. Not having dogs and cats vaccinated against rabies after four months of age is a Class C Misdemeanor punishable with a \$300 fine (THSC Chapter 826). The enforcement of this very State of Texas law could be the key to encouraging pet owners to take responsibility to vaccinate their pets and this step often leads to the next step in responsible ownership—sterilizing pets. The second law is one that most are not familiar with—"Dogs Dangerous to Other Animals" law (THSC Chapter 822, Sub-Chapter B) where "the owner or keeper of a dog that the person knows is accustomed to chase or kill livestock, domestic animals (yes, your cat), or fowl (yes, your chickens) may not allow the dog to run at large. The penalty of the owner who allows his dog to run at large is in violation and can be punished with a fine not to exceed \$100." Sloppy, irresponsible habits of pet owners can be corrected with education and the proactive enforcement of laws and the very real risk of fines.



The War Years and Afterward

<u>1944</u> - Brought sad news in relation to the war. Friday night, February 11, 1944 a memorial service was held for Clarence (Pete) Fuller, who was killed January 20, in North Africa. He was a Night Fighter Pilot.

<u>December 1944</u> - We received word that Tom Wilson had given his life for his country. He was injured with the sinking of his ship the U.S.S Henley. He was first listed as missing in action, but later it was found that he died from the injuries sometime later. There was no mention of his brother Byron who was also on the same ship.



<u>July 1945</u> – Mr. Hawkins told us to get our chores done in the morning, to have a July 4th celebrations that day. We went to the lake for swimming after lunch we played some games until milking time, after supper we gathered in front of the Dinning Hall to finish our 4th celebration. It started raining and we had to finish inside. By James Cammack.

<u>December 1945</u> – Mr. Hawkins took the boys in Demaree Cottage on a possum hunt. We used our new flashlights we got for Christmas in our boxes. We chased armadillos, and Mr. Hawkins killed a possum. Then we sat down and ate apples and candy. I think all the boys really enjoyed the possum hunt. By Jerry Dyer.

<u>April 1946</u> – Marvin Allen has just been discharged from the Navy and has spent a few days here at the Home. Ralph Tucker also has visited us. Ralph also was recently discharged; he was with the Marines in the Pacific. Gene Strickland also spent a weekend here recently. Anne Pace also has been a visitor. We the staff are pleased and gratified that these young people choose to come back and visit after they have left the Home.

<u>May3 1946</u> – We attended the horse show in Itasca. We rode our horses in the parade. Mr. Hawkins rode his own. It is a five gaited "Tennessee Walking Horse." The horse show was a big event, with soldiers, air show, tanks and other army vehicles. Article by J.B. Stovall.

October 1946 – At this time the tennis courts are being built along with a new swimming pool, also an addition to the laundry. The boys do ironing in the old part and girls in the new. The boys run the presses, wringers and mangelers, the girls do most of the ironing. By Mattie Bell McFord.

<u>September 1946</u> – The prize steer at the Dallas Fair was purchased by Mr. John W. Carpenter of the TP&L Company and donated to the Presbyterian Home here. Don Nicholson and J.B. Stovall went to Dallas to accept the steer on behalf of the Home. Mr. O.M. Harrell of Hillsboro TP&L participated.

April 1947 – In the past few weeks we have had 75 or 80 cases of the flu. Thankfully, most of the cases were light.

<u>June 1947</u> – Again this year we participated in the Itasca Horse Show. We had seven horses in the parade. We wish to thank everyone who made the horse shows possible. We always enjoy them. By Bobby Parkis.

<u>January 1949</u> – The men's Bible Class of the Dallas Presbyterian Church asked Mr. Hawkins what we needed badly. He replied, "A new barn, combination hay storage and milking area out of the weather. They along with Mr. Dave Metzger, a Dallas Dairyman started the fund for the facility. Mr. Metzger donated \$1,000.00. Now we have a place to feed, store and milk the cows. Article by James Cammack.

October 1951 – A wedding ceremony was performed recently in the home of Mr. & Mrs. Nelson Hawkins. Miss Jemmie Reid and G.C. Kemp were united in marriage. The ceremony was performed by Rev. Nelson Hawkins, Miss Julia Struve was the pianist, Miss Betty Sumner was soloist, and Jemmie was a former member of the Miller Cottage before leaving and graduating from Texas Technological College in Lubbock.

<u>February 1952</u> – This has started out to be a banner year for the Home. We have acquired three new vehicles. First Mr. and Mrs. Edwin Flato of Corpus Christi presented us with a new 48-passenger bus; we really needed this because we have 27 students this year going to school in Itasca. This is besides the other trips we make to various places. The men's Bible Class of the First Presbyterian Church in Dallas took our old station wagon and traded it in on a new one. Our friends of the First Presbyterian Church in Fort Worth took our old pickup and traded it in for a new one and presented it to us. Needless to say; we are extremely grateful for their generosity. We could not do without our friends everywhere. They greatly aid and enrich our lives here at the Presbyterian Children's Home.


