

The Performing Arts Series at Hill College began with two dynamic groups, representing opposite ends of the musical spectrum, the Dixieland strains of Jim Cullum's Band and the rich choral renderings of the State Symphony Capella of Russia. Next to grace the college stage will be a splendid soloist, violinist Elena Urioste. The performance takes place at 7:30 pm, Tuesday, Nov. 16 in the Gov. Bill Daniels Auditorium of the Vara Martin Daniel Performing Arts Center, just behind the Texas Heritage Museum on the Hillsboro campus and is free and open to the public. No reservations are required. A reception with the artists will be held immediately following the



event in the south PAC, sponsored by the Hillsboro Monday Review Club. More information

Elena is a graduate of the Curtis Institute of Music, where she studied with Joseph Silverstein, Pamela Frank, and Ida Kavafian. She completed graduate studies with Joel Smirnoff at The Juilliard School. Her instrument is unique, an Alessandro Gagliano, from Naples, c. 1706. Along with a Pierre Simon bow, it is on extended loan from the private collection of Dr. Charles E. King through the Stradivari Society of Chicago.

Ms. Urioste has been hailed by critics and audiences alike for her lush tone, the nuanced lyricism of her playing, and her commanding stage presence. Elena's debut performances with the Chicago Symphony Orchestra in 2010 were praised by three separate critics for their "hypnotic delicacy," "expressive poise," and "lyrical sensitivity." Since first appearing with the Philadelphia Orchestra at age thirteen, she has made acclaimed debuts with major orchestras throughout the United States and Europe.

As first-place laureate in both the Junior and Senior divisions of the Sphinx Competition, she debuted at Carnegie Hall in 2004, where she has returned annually as soloist, made her Wigmore Hall recital debut in 2009 as one of three recipients of the prestigious London Music Masters Award and, earlier that year, debuted at Lincoln Center's Alice Tully Hall. Her media credits include the popular radio programs From the Top and Performance Today, NBC television's Today Show and a McGraw Young Artists Showcase performance for a live studio audience at WQXR's Greene Space in New York City. She is featured in the Emmy award-winning documentary Breaking the Sound Barrier and in numerous magazines including Symphony, Strings, Philadelphia Music Makers, and Careers and Colleges. Her first CD was released on the White Pine label.

Ms. Urioste will be accompanied at the piano by Dr. Vincent de Vries. Dr. de Vries is an active performer, presenting recitals as soloist, duo pianist, accompanist, and organist. He received his Doctor of Musical Arts degree from The University of Texas at Austin and holds a Performer's Diploma from The Royal Conservatory in The Hague, The Netherlands and a Master's degree from Bowling Green State University. Having held positions at both the University of Texas at Austin and Baylor University in Waco, he has recently accepted a position at Yonsei University in Seoul, South Korea.

In addition to his piano performances, Dr. de Vries is a highly regarded concert organist, with over three hundred solo recitals and eight organ solo CD releases to his credit. In 2003 he received the silver medal from the "Arts, Sciences, et Lettres" in Paris for his contributions to the French organ literature. His recent CD releases include "Into the 21st Century: music for horn and piano" and "In a Lyrical Way" with Jeffrey Powers and a recital featuring the works of Brahms, Poulenc, Rachmaninoff, and Milhaud with duo pianist Dr. Bradley Bolen. All recordings were released on the MSR Classics label. Two world-class artists on one stage. Make plans now to join us for this evening of wonderful music in the classical tradition.

#### Abandoned and Junked Vehicles

Citizens are once again reminded of the Abandoned &/or Junk Vehicle Ordinance. A "junk vehicle" is any vehicle that is inoperable, does not have lawfully attached to it an unexpired license plate, a valid motor vehicle inspection certificate, is wrecked, dismantled or partially dismantled or discarded, and has remained inoperable for more than 72 consecutive hours, if the vehicle is on public property or 30 consecutive days, if the vehicle is on private property.

Monishia and her family moved to Itasca after their house in Italy caught fire and burned to the ground. She has managed to overcome the tremendous loss that has shaped


her into the very talented young lady she is today.

#### **September City Council Meeting**

The Itasca City Council met in a regular session on Monday, September 20, 2010 in the Council Chambers, 136 N. Hill St., Itasca, Texas. Mayor Matthew Fehnel called the meeting to order at 6:02 p.m. Members present were James Bouldin, Denis Heyse, Doug Farquhar and John Laird. Councilwoman Susie Davis was absent, Also present were City Administrator Mark Gropp and City Attorney Stephanie Johnson.

Motions were passed to approve the August 23, 2010 meeting's minutes and to pay the bills as presented. Monthly Department and Committee reports were given as follow by Wayne Upchurch (Water/Sewer Operations), IPD Chief John Griscavage (IPD), Wayland Price (IV Fire Department), (Planning and Zoning Committee), (Office of Code Enforcement) and (Building Standard Commission).

Judi Underwood gave a presentation regarding her request to discuss property destruction of 801 E. Main, Itasca, Texas 76055 more particularly described as Files & Chiles Blk 4 Lot 5& 6. There was a discussion and the Council requested Ms. Underwood to give a time line to bring the buildings up to code. A time line was agreed upon by Ms. Underwood and the Council.

Harry Fuller and Glen Vipperman, representatives of Atmos Energy – Mid-Tex Division, addressed the Council for consideration of an ordinance/resolution to approve Atmos Energy Rate Review Mechanism Extension, rate increase and recovery of steel service line replacement program costs. The impact for an average residential customer (using 4.5 Mcf a month) will have an increase of \$1.40/month and an average commercial customer (using 34.2 Mcf a month) will have an increase of \$3.82/month. A motion agreeing to the increase was made and passed with the waiving of the second and third readings.

Allied Waste requested a rate increase to reflect the increases in the Consumer Price Index (CPI-W) and fuel costs. Allied Waste Services Representative Laura Capehart presented the request to the Council. She explained the annual CPI calculation is per contract with the City. Allied is requesting an increase of 3% and the effective date of said adjustment should be October 1, 2010. The new rate for residential curbside will be \$11.02/month and commercial handload will be \$12.44/month. The Council approved the rate increase.

A resolution authorizing submission of a Texas Community Development Program application to the Texas Department of Rural Affairs, authorizing the Mayor to act as the City's authorized representative, and committing the City's local share toward the grant for sewer system improvements was presented to the Council from Grant Development Services and was approved. The Hill County Emergency Services District No. 1 (ESD #1) proposed contract agreement for the City of Itasca to provide fire department services was considered. There was a discussion that ESD #1 did not disclose an amount (dollar amount) of what ESD #1 will pay the city for fire department services and the Council decided to table the matter until the October meeting. The Agreement for Mutual Aid in Fire Protection and Other Emergency Services between the entities and/or emergency services organizations was approved.

The first reading to adopt Ordinance #902010-2 Levying an Annual Ad Valorem Tax for the Year 2010 Setting Specific Tax Rates, Applicable to All Real, Personal and Mixed Property Situated Within the City of Itasca was read by the Mayor. The tax rate will raise more taxes for Maintenance and Operations than last year's tax rate. A motion approving and adopting an ad valorem tax rate for Maintenance and Operations for the general fund of \$ .5726 per \$100.00 cash valuation, waiving the second and third readings, was made and passed. Tax rate to ratify the property tax increase reflected in the fiscal year 2010-2011 Budget was approved also.

The City Secretary presented to the Presiding Officer of the Governing Body a Certification of Unopposed Candidates for the election schedule to be held on November 2, 2010. The following candidates are unopposed for election to office: Mayor-James "Boogie" Bouldin, Alderman-Denis Heyse and Alderman-John "Skipper" Laird. The Council approved and passed an Order of Cancellation for the November 2, 2010 election. With the approval and cancellation James "Boogie" Bouldin was certified as the unopposed and hereby elected Mayor, Denis Heyse and John "Skipper" Laird are certified as unopposed and hereby elected alderman. Resolution #092010-2 re-adopting the City's Investment Policy was adopted and approved.

The meeting adjourned at 7:15 p.m.

#### Final Notice and Public Explanation of a Proposed Activity in a 100-Year Floodplain

To: All interested Agencies Texas Historical Commission, Texas Parks and Wildlife, U.S. EPA Region VI, U.S. HUD Forth Worth, Heart of Texas Council of Governments (HOTCOG), Texas Commission on Environmental Quality (TCEQ) Groups and Individuals in Hill County.

This is to give notice that The City of Itasca has conducted an evaluation as required by Executive Order 11988 and/or 11990, in accordance with HUD regulations at 24 CFR 55.20 Subpart C Procedures for Making Determinations on Floodplain Management, to determine the potential affect that its activity in the floodplain and wetland will have on the human environment for Wastewater Treatment Plant Improvements under Texas Community Development Block Grant (TxCDBG) Texas Department of Rural Affairs (TDRA) Contract No. 710351.

The City of Itasca shall address a Texas Commission on Environmental Quality (TCEQ) Notice of Enforcement Order for deficiencies at the city's wastewater treatment plant. There is an urgency to bring the operation of the wastewater treatment plant into specifications as set forth according to TCEQ's rules and regulations. The City received multiple violations resulting from the malfunctions of the wastewater treatment plant, causing potential health, safety and environmental problems for all concerned.

Construction shall include the installation of one (1)[ generator with concrete pad, automatic transfer switch, standby power electrical connection, fencing, two (2) clarifier internal replacements to include bridge, scraper, baffles, weirs, drive and sludge arms and sludge valves and all associated appurtenances. Construction shall take place at the city's wastewater treatment plant located at the south edge of the city, southeast of the intersection of Highway 891 and Texas 176 Spur, City of Itasca, Hill County, Texas. The environmental clearance area includes the encompassing area where the existing plant is now located. Improvements will be in the area where the wastewater treatment is now located and is of urban use of natural values and is located within the hazard 100-year floodplain. Acreage of construction located within the floodplain is .20 acres.

The City of Itasca has reevaluated and considered the above activities and determined that it is necessary to make the improvements. The activities will have no significant impact on the environment. The County will use mitigation measures to minimize the adverse impacts and restore and preserve natural and beneficial values of the area consistent with state and federal statutes and regulations including best management practices to avoid negatively impacting the local area.

There are three primary purposes for this notice. First, people who may be affected by activities in floodplains and those who have an interest in the protection of the natural environment should be given an opportunity to express their concerns and provide information about these areas. Second, an adequate public notice program can be an important public educational tool. The dissemination of information about floodplains can facilitate and enhance Federal efforts to reduce the risks associated with the occupancy and modification of these special areas. Third, as a matter of fairness, when the Federal government determines it will participate in actions taking place in floodplains, it must inform those who may be put at greater or continued risk.

Written comments must be received by the City of Itasca at the following address on or before November 15, 2010, a minimum 7 calendar day comment period will begin the day after the publication and end on the 7th day after the publication: City of Itasca, City Hall, 126 N. ## Remember When ... "Early Days in Texas"

We have had lots of stories about the early days and people's everyday lives and their tools, clothing, social life, and other activities connected to earlier times. Some of it could be considered history but not "History" as such. I have always loved history whether it is ancient, medieval, world, U.S. or good old Texas History. I thought perhaps some of the readers might share this interest and a little Texas History might be in order.

Of course when we think of Texas History, we think of cowboys and the cattle industry, and the men and women who developed it such as Charles Goodnight, a Mr. Loving and the cattle drivers who were the inspiration for the T.V. series "Rawhide." We must also not forget the part the Indians played during the development of the state.

Charles Goodnight and his family lived in Colorado. When he was grown, Charles established a ranch there. After the financial turndown in 1873, Mr. Goodnight drove 1600 head of cattle to Texas. In 1877 he met a wealthy Irish financer whose name was John G. Adair. They formed a partnership, and executed a five year contract. Adair furnished the money and Charles Goodnight operated the ranch. At the end of five years Goodnight would get one third and Adair two thirds. Adair died in 1885 and two years later Goodnight sold out and moved to a smaller ranch. A town called "Goodnight" eventually developed nearby.

In earlier years Charles Goodnight and a man named Loving established the Goodnight-Loving Trail. It was during the time when lots of cattle were being driven north to markets in Wichita and Abilene, Kansas and other places.

About 1865 Charles met Molly Dyer, who was from Tennessee. Her father was a lawyer and her grandfather was the first governor of Tennessee. We wonder why they would want to come to Texas, but they did in 1854. Molly's mother died in 1864, and her father two years later, leaving Molly to take care of three younger brothers. She taught school; herself being home schooled by her parents. One day Molly was on horseback taking a younger brother to school, when on the way back she stopped at an Inn for travelers which was owned by Charles Goodnight's mother. It was here that she met Charles. Mr. Goodnight hired Molly's older brother for a cattle drive. It was then that Charles and Molly started dating. They courted for five years that is, when he wasn't gone on business or cattle drives. They married July 20, 1870. She was still taking care of her two younger brothers. Eventually Mr. Goodnight took them in and gave them jobs as they became older.

When John Adair died his family left. This left Molly the only white woman within two hundred miles. The cowboys called her "The Queen of the Palo Duro Canyon." She and Charles never had children. She cared for the hired hands, took care of their clothes and hosted all social events at the ranch. She even taught some of the cowboys how to read. She had a medicine kit to take care of minor ailments as there were no doctors for miles. Molly went with Charles on a couple of cattle drives and did the cooking on the drive.

Charles and Molly occasionally welcomed Quanah Parker to their home. As we remember, he was the son of Cynthia Ann Parker, who was kidnapped by Indians at Fort Parker near Mexia. She lived with the Indians for years and married a chief, Quanah was their son. It is said that when she was "rescued" by the whites, they would not allow her to go back, and she grieved herself to death.

Charles Goodnight has always been credited with saving the buffalo, but Molly also was a major factor. When the buffalo were slaughtered for their

hides they killed them all except the young calves. It was not economically feasible to process the calves, therefore the smaller ones were left to die. Molly asked Charles and the cowboys to bring the young calves to the ranch. Some of them she fed with a bottle. Charles was sympathetic to the operation and that is the way their herd was started. Later, Mr. Goodnight crossed the buffalo with cattle, and called them "Cattalos." There is another buffalo in Canada that is slightly different from the U.S. strain. They are called wood buffalo. They were also saved.

After many years of running the ranch and developing the country, Charles and Molly lived a happy life, in 1926 at the age of 86, Molly died. A year later on his 91<sup>st</sup> birthday Charles Goodnight married his nurse. Their marriage was to last only a short time, for Charles died in 1929 at the age of 93 year; he was buried beside Molly. They had been married fifty six years.

And so we bring an end to one story about early days in Texas
