Public Notice – 3rd Posting Abandoned & Junk Vehicles

The Office of Code Enforcement would like to inform the community concerning abandoned and junk vehicles, in hopes that it could encourage our citizens to abide by the Itasca Code of Ordinances and continue the beautification of our city.

A "Junk Vehicle," is defined as a vehicle that is selfpropelled and inoperable and does not have lawfully attached to it an unexpired license plate and a valid motor vehicle inspection certificate, wrecked, dismantled or partially dismantled or discarded, and has remained inoperable for more than 72 consecutive hours, if the vehicle is on public property or 30 consecutive days, if the vehicles is on private property.

Anyone violating this ordinance will be sent a Notice of Violation letter informing the property owner/vehicle owner to remove the vehicle(s) within 10 (Ten)-calendar days. If the vehicle(s) are not removed within the stated time and a hearing has not been requested, a citation will be issued and the vehicle(s) will be removed from the property.

"It's not about the money," Chris said, "It's for the love of rodeo and for the recognition."

When Harris began riding at the age of nine, he rode bulls. Not being the best in the event, a friend dared him to ride a bareback horse. He took the bet and found his natural calling.

"It was the most natural thing I've ever done." Harris said. "Riding barebacks includes a lot of body control and is very physically demanding. In my "younger days" I needed very little physical training but now I work out 4-5 days a week in a

gym."

Harris rode in college and has competed in rodeos all over the United States, in Calgary, Canada and in Brazil since turning pro. He has a career earning of \$454,321. Some of his career highlights include the Texas Circuit Finals '96, Calgary Stampede '98, Royal Rodeo, Cowboy Capital of the World Rodeo, Caldwell Night Rodeo '99, Star of Texas, Jaycee Bootheel Rodeo '00, Cloverdale Rodeo, Dinosaur Roundup Rodeo, Navajo Nation 4th of July Celebration '01, Canadian Pro Rodeo, Clackamas County Fair & Rodeo, Lewiston Round-Up,'02 and Belton Fourth of July Rodeo '04.

Harris' wife, Stephanie, barrel raced for many years and has competed at some of the same rodeos as her husband.

"It's much more enjoyable when she's with me." Harris said.

Harris is not only a cowboy and a husband; he is the father of a little four year old girl, Jessie James Harris, who thinks her dad is the world's greatest cowboy.

"It is hard to leave my family for long periods of time while I rodeo," Harris said. "It is wonderful when they are there with me cheering me on."

In the last few years, Harris has realized that with fame comes responsibility. In February 2006, he joined with country singers Willie Nelson, Clay Walker and Lynyrd Skynyrd and cowboys Luke Branquinho and Buck Taylor in visiting wounded veterans at Brooke Army Medical Center in San Antonio. Harris and the soldiers shared a number of injury stories.

The 2007 rodeo finals in Las Vegas are a bright thought in Chris' future.

"I am working hard to bring home that trophy, but I will continue to ride for a while. I am not ready to quit, but when I do stop competing I would like to start a business that includes guided hunts."

Harris said that he has broken numerous bones and he realizes that as he gets older – he is over thirty, old for a bareback rider – the arthritis will start to slow him down, but he is not ready to quit yet. He had already been hard at work in 2007 riding in a number of rodeos including Fort Worth last week.

"The quote I have lived by throughout the years is," Harris said, "the only death you'll ever die is the death you die everyday by not living."

"Hill County Day in Austin" Scheduled

"Hill County Day in Austin" will be held at the state capitol Wednesday, February 21. The trip gives local residents an opportunity to see their legislators at work on the floors of the House of Representatives and Senate and in committee hearings.

Activities for the day include a group picture on the south steps of the capitol, attending the opening ceremonies for the House and Senate, a Dutch-treat luncheon and presentations by representatives from various state agencies. The Hillsboro Chamber of Commerce, along with chambers from Lake Whitney, Hubbard and Itasca, is hosting the event.

For the second straight session, two buses have been chartered for the trip. Serving as gold sponsor for the trip is HILCO. Other sponsors include AT&T, TXU, Hill County Farm Bureau and Wells Fargo Bank-Hillsboro and Hubbard.

State Representative Jim Pitts and State Senator Kip Averitt are scheduled to speak at the luncheon, which will be held at Spaghetti Warehouse. The old Court of Criminal Appeals' chambers on the third floor of the capitol has been reserved for afternoon presentations.

Representatives with the Texas Department of Transportation, Texas Education Agency, Texas Parks and Wildlife Department, Texas Railroad Commission and economic-development officials from the governor's office are scheduled to speak.

For those interested, special tours of the capitol complex have been scheduled for 2 p.m. and 2:15 p.m. They start near the south doors of the capitol. Buses will leave the Hillsboro Chamber of Commerce on North Covington Street at 6:45 a.m. and will return at approximately 6:30 p.m. Cost of the trip, including lunch and the bus, is \$25 per person. For individuals taking their own vehicles and wishing to attend the lunch, the cost is \$15.

Church Group, Business Honored for Service to Community

The Chamber of Commerce presented the Itasca branch of the Angel Food Ministries, a non-profit, non-denominational organization dedicated to providing first-quality food to communities throughout the United States with a Service to the Community award.

Angel Food Ministries began in 1994 in Monroe, Georgia and now serves hundreds of thousands of families every month in 32 states.

In Itasca, the program is hosted by First Presbyterian Church and includes the participation of eight other churches in Hill, Ellis and Johnson counties. When the program started locally in October 2005, 91 boxes of food were distributed, but that quickly grew to 468 boxes in December 2006, distributed locally. In the last 14 months, over 4675 boxes of food have been distributed locally.

"This is making a significant impact on hunger in our community," Chamber Director Sue Rivera said as she presented the award.

First Presbyterian Church of Itasca, the George G. and Alva Hudson Smith Foundation, Leach Trailer Sales, and the Presbyterian Children's Home have supported the project corporately.

The owners of Leach Trailers, Doug and Davonia Leach, began the business sixteen years ago at the owner's house and shop in Burleson. Twelve years ago they purchased land and a building in Itasca from the bank and moved the business to Itasca. The business manufactures and installs dump bed, and builds pup trailers, end dumps, and belly dumps. They employ 22 people.

The Chamber honored the business for all of the help they give Itasca. Anytime Itasca needs equipment, Leach Trailers is quick to loan the city their big trucks, backhoe or welding equipment along with the labor, many times. They also helped Angel Food Ministries get started by furnishing machinery, labor, and welding.

House Passes 2007 Joint Funding Resolution Increasing VA Healthcare Budget by \$3.6 Billion

U.S. Representative Chet Edwards today announced that the fiscal year 2007 Joint Funding Resolution passed by the House includes a \$3.6 billion increase for veterans' medical care under the Department of Veterans Affairs budget, \$3.4 billion overall. Edwards, Chairman of the House Appropriations Subcommittee on Military Construction and Veterans Affairs, emphasized that while the increase is significant, the level is consistent with the need to keep up with health care inflation and the increasing number of veterans coming into the VA health care system. The House passed the bill 286 to 140.

"This increased funding level is good news for America's veterans, because it provides \$278 million dollars more a month for the VA health care system compared to the budget passed by the previous Congress. The sooner this bill is passed and sent to the president, the better, since continued funding of the VA at 2006 levels could force harmful cuts in health care services for hundreds of thousands of veterans due to health care inflation and the increasing number of veterans using the VA health care system."

As Chairman, Edwards fought for a significant increase in VA health care funding, despite the tight budget constraints enacted by the previous Congress.

"I will never understand why the previous congressional leadership refused to pass the veterans' health care funding bill, instead allowing funding to proceed for the last four months at last year's funding levels. This bill will correct that wrong," said Edwards. "Our veterans have kept their promises to our nation, and we felt it was our duty to keep our promises to them. I applaud Chairman Obey for writing a bill that clearly makes veterans our top priority."

The following are the totals for VA and military construction: Veterans Healthcare: \$32.3 billion, an increase of \$3.6 billion above the fiscal year 2006 funding level to provide service for an anticipated increase of at least 325,000 patients and to meet rising healthcare costs. VA discretionary total is \$36.5 billion, an increase of \$3.4 billion above fiscal year 2006 funding level. Fully funded pay raises (other agencies only receive 50% of pay raise). Military Construction: \$6.2 billion for military construction, \$4 billion for family housing program, U.S. Army would receive \$250 million more than fiscal year 2006 level. BRAC accounts will receive a \$1 billion increase above the fiscal year 2006 level, for a total of \$2.5 billion.

"While this bill did not fully fund the BRAC accounts for 2007, Congress will have the opportunity to address the rest of the funding requirements in the upcoming Fiscal Year 2007 Supplemental, which should be passed in the spring," said Edwards.

The bill now heads to the Senate.

Animal Control in Hill County Non-Existent

Based on a pet population formula provided by the Humane Society of the United States (HSUS), over half American household have 1.6 dogs and/or 2.1 cats. This equates to some 11,325 dogs and 16,914 cats living in Hill County (total of 28,239 pets). These figures are estimates of household pets only and do not include the estimated thousands of unwanted dogs and cats that are "dumped" each year in our rural areas. Hill County's pet overpopulation issue is a direct result of irresponsible pet owners who do not sterilize their pets and allow them to roam and proliferate at will. We live in a county where 70% of our population lives in areas without animal control services. One pair of uncontrolled breeding dogs can produce 4,372 offspring in just four years; cats can produce 420,715 offspring in this same period.

Even with a State Law that makes it mandatory for pets to be vaccinated against the rabies virus, many owners are negligent and refuse to comply. It is not known how many pets in Texas do not get rabies vaccinations, but estimates run from 50-70% of pets being unvaccinated or not current on vaccinations. This is a significant number for Hill County. Based on our county's estimates of pet population, there are potentially 14,119-19,767 dogs and cats not vaccinated in Hill County (based on the 50-70% range estimate).

Pet overpopulation burdens each of our citizens and our community as a whole with health, economic, legal, and safety liabilities.

Do You Remember . . . ? – "Idioms or Sayings"





Recently we have had columns about human interest, personalities, school, peddlers, etc. maybe now we should have something in a lighter vein. I think it is good to laugh at ourselves occasionally. Most of the following are things we older ones have heard over the years.

Webster says that an Idiom is a speed form that is peculiar to itself within the usage of a given, a specialized language, or jargon. In years past we called them "sayings". No matter what they are called, they have a way of emphasizing a point that cannot be otherwise described, even by the use of six-bit words used by more learned conversationalists. Most of the

young readers have not been exposed to such quaint expressions.

Take the word, "shifty", we knew that it meant a person you could not trust in the smokehouse with a butcher knife, or if you sleep with dogs, you will wake up with fleas, which means, if you can expect a sorry reputation if you run with sorry folks. Another is that he is studying to be a half wit, and he is halfway there and he was grinning like a mule with a mouthful of briars.

If a person was hard to pin down, he's like trying to hem up syrup with half a biscuit. An extremely inebriated person was described as "knee walking, commode hugging drunk." We used to idle our cars down to see whose could run the quietest. One guy said his was quieter than a mouse wetting on a bale of cotton. Now that's quiet. Some expressions had to do with ugliness. "He was so ugly we had to hang a pork chop around his neck so the dogs would play with him." "Don't ever kiss an ugly girl; she will tell the whole town." Or the ultimate of ugly was she has a smile like a wave on a slop jar, or she is as common as hog tracks.

Being raised on a farm and having spent a lot of time around animals, I remember some of animal sayings such as: "His hogs are so poor, they have to stand up twice to make a shadow." "He was grinning like a dog eating yellow jackets." "Even a blind hog finds an acorn once in a while."

In describing someone with a big mouth instead of just coming right out and saying so, we would say, "He can bite through a side of bacon without greasing a gum!" Then you might describe a person's honesty by saying, "If he tells you a hen dips snuff you will find a brush under her wing."

We sometimes described a family's financial situation with "Those folks are too poor to paint and too proud to whitewash." "They don't have a pot or a window to throw it out of."

Other sayings in no special category or order were: "I hear you clucking, but I can't find your nest; he was as regular as a goose goes barefoot; he came around here big eying around; he is as useless as hip pockets on a hog." We used the following expressions to describe someone's intelligence or the lack thereof. "He's not playing with a full deck." "His elevator doesn't go to the top." "He's about a half bubble off." "He doesn't have both oars in the water." To describe an attractive young lady we would say, "She is as pretty as a speckled pup under a red wagon."

There were many more of those sayings we used in those days. Some of them I cannot list here, at the advice of my censors.
