Itasca High Receives National Recognition

Reporter Ashley Durham Some Information from U.S. News & World Report



When it was announced over the morning announcements that Itasca High was featured in U.S. News & World Report and on Channel 10 News as being one of the best high schools in the U.S. the student body just nodded and continued with their work. The teachers were very excited and proud but the students seem to take no notice. When questioned, they replied that they knew they had the best high school, but they were glad that the rest of the country now knows it, too.

Eleven Central Texas high schools were listed among the nation's best in a new U.S. News & World Report survey that analyzed enrollment and academic data from high schools around the country. A total of 18,790 schools were analyzed, but only 1,086 of the schools were identified as medal winners. The schools were picked based on performance on state tests, how well as how the disadvantaged students performed and whether the school provided college-level coursework.

IHS was honored as a bronze medal school. A bronze medal school does not offer AP classes, or does not achieve a college readiness index of at least 20, (according to their criteria) but they do successfully meet other two key performance indicator criteria. The survey did not take into account that students graduate from IHS with 27-30 college credit hours. It only grades on the AP classes.

Last year during the study, Itasca had 203 students enrolled with 42.4% labeled as minority and 58.1% labeled as disadvantaged.

"We are very honored by this achievement," Superintendent Glenn Pittman said. "We would like to thank all the teachers, staff members, parents and student for helping us achieve this."

IHS Grad & Friends Establish AliveCampain.org in Support of Friend

On November 3, four **Baylor University students** were eating dinner with a friend when he revealed to his friends that he had been seriously considering Kyle Ferguson, suicide. Justin Brown. Steve Zimmerman. and Nathan Lloyd, Itasca graduate of 2005 (pictured above), spent the rest of their dinner offering reasons for living and encouragement to the friend whose identity

they meticulously kept secret.

On the way back to their homes, Lloyd, Ferguson, Brown and Zimmerman decided to do something to encourage their friend. They wanted to give him the support he needed. Many ideas were considered, but by the time they arrived at home, they had a plan.

The four college students set up a Facebook.com page called the Alive Campaign, which focused on suicide awareness. They pledged that if they hit their goal of 250,000 online members, they would take a 4300-mile biking trip. The journey would take them from Waco, Texas to Anchorage, Alaska this summer. Andi Nakasone will record the whole trip on film.

Lloyd, Ferguson, Brown, and Zimmerman launched the Facebook page on November 4. By 10:45 that night, it had 100 members. The site quickly grew. It had 5,000 members by 12:46 a.m. on November 6 and 10,000 members by 3 p.m. on November 10. The website reached the 250,000 goal as of 7:15 p.m. on November 17. It currently has over 300,000 members.

On the site, people bring encouragement and hope to others who may be contemplating suicide. Many times, they do not even know the person they are encouraging. People around the world have offered advice on suicide prevention, training tips, suggested routes to take to Alaska, and much more.



Do You Have a Dog that Chases and Kills Livestock or Fowl

Press Release

Pet ownership requires responsibility. Several Texas laws exist that encourages this responsibility. The most frequently violated law is the Texas Rabies Control Act (Texas Health and Safety Code, Chapter 826) which requires all pet owners to vaccinate (and keep current) their pets against the deadly rabies virus after four months of age or face Class C Misdemeanor violationscarries up to a \$300 fine. Another law that is frequently violated in our county is the abandonment of dogs and cats. This vile act is included with animal cruelty laws and becomes a Penal Code 42.09 violation, which is a Class A Misdemeanor with fines up to \$4,000 fines and/or year in jail. Another law is the regulation of dogs dangerous to animals, (Texas Health and Safety Code Chapter 822, Subchapter B). This law specifies that in all counties, the owner or keeper of a dog that is known to chase or kill livestock, domestic animals, or fowl may not allow the dog to run at large. The owner who allows his dog to run free is in violation and can be punished with a fine not to exceed \$100.

The majority of households within Hill County (60%) are located in areas without local (city) law enforcement and/or animal control. Therefore, the burden falls on the Sheriff Office to enforce these existing animal control laws. It is your civic duty to report violations of Texas law. If you live outside city areas where local law enforcement is not available and you need to report a violation, call the Hill County Sheriff Office at 582-5313—<u>they</u> <u>are employed to serve and protect</u>.

Pet ownership is a serious responsibility. Over 28,239 pets live within Hill County households. Because 60% of households are outside areas without basic animal control, over 16,943 household pets are in areas that are not regulated. Statistics shows that up to 70% of pets living in Texas remain unvaccinated or not current for the deadly rabies virus. These unvaccinated pets live with our families and are in contact with our children! These figures do not include the hundreds of "homeless strays" in our county. Another alarming note is that our county allows "packs" of dogs to run at will which is dangerous. Are we waiting for another "Lillian" incident to occur? Lillian Stiles was the 76 year old lady who was attacked and torn apart alive to her premature death by a pack of "stray" dogs. Hill County needs to take a proactive approach to its ever worsening pet overpopulation issue by establishing basic animal control-a necessary core service. Community leaders and representatives must embrace proactive measures and prioritize the hazard of pet overpopulation towards correction (the word proactive is the key word in the last three sentences). The implicit facts remains that pet overpopulation will not correct itself.

October City Council Meeting

The Itasca City Council met in a regular session on Monday, October 15, 2007 in the Council Chambers, 126 N. Hill, Itasca, Texas. Mayor Matthew Fehnel called the meeting to order at 6:01 p.m. Council members present were James Bouldin, Susie Davis, Steve Solis, Harvey Wilson and John Laird; City Administrator Mark Gropp and City Attorney Stephanie Johnson.

The minutes for September 17, 2007 meeting and the bills were approved for payment by unanimous vote.

In the department reports, Fire Chief Chris Shuffield reported that the volunteers had made a profit of approximately \$1800 from the Bull Riding Fund Raiser.

Wayne Upchurch's reported that the water and sewer operations was running smooth. Susie Davis gave the Planning and Zoning Committee report and she informed the council that Doug Farquhar was interested in becoming a member of the committee. The meeting time has changed from 5:30 p.m. to 6:00 p.m. Officer Albert Sanchez explained the police report and Mayor Fehnel gave the Office of Code Enforcement report.

Rick Holden, representative for Atmos, asked the Council to take action on Atmos Energy Corporation's request on the Statement of Intent to Increase Gas Utility Rates. The increase will be \$1.57 per month for a residential customer and \$9.21 per month for commercial customers. Holden requested that the City take final action on the Statement of Intent before October 25, 2007 by passing an approval ordinance or by taking no action and allowing the request to be approved by operation of law. A motion to approve and accept Resolution #101507 to suspend the filing was made; unanimous vote.

City Attorney Stephanie Johnson explained a revised ordinance on peddlers with the recommended corrections. Mayor Fehnel read the ordinance. A motion to accept reading, approve and adopt the ordinance was made, waiving the second and third reading; passed; unanimous vote.

The City Secretary gave an update regarding the changing of the General Election Date to another authorized uniform election date. The state election division was contacted, they explained there is no law open right now for a governing body of a political subdivision to change the date on which it holds its general election for officers. The city will not be able to change the date until a new law is open.

The General Law Handbook for Mayors and Council members was distributed. The Council discussed an increase in water deposits, late notice, and after hour charges for reconnect. A motion was made to set a: \$100 water deposit, \$10 late notice, \$50 during hours reconnection fee, and \$100 after hours reconnection fee; passed: unanimous vote.

During the Mayor, Council and City Administrator discussion and reports, the City Administrator announced that the Open House is scheduled for December 10, 2007. The meeting adjourned at 6:48 p.m.

October IISD Board of Trustees Meeting

The Board of Trustees of the Itasca Independent School District met in regular session on Monday, October 8, 2007, in the Itasca ISD Administration Building at 7:00 P.M., President Marquita Lloyd presiding. Board member present were Marquita Lloyd, Claude Garrett, Donny Faries, Nancy Bowman, Susan Bason, and Kevin Cordell. Kevin Lightsey was absent.

Administration present were Glenn Pittman, Superintendent, Rickie Harris, High School Principal, Larry Mynarcik, Middle School Principal, Karon Farquhar, Elementary Principal, Barry Durham, Finance Director and Norma Merkel, Secretary.

Motions were made and passed to approve the minutes from the previous board meeting and to approve the bills and financial report.

Motions were made and passed to accept the Financial Integrity Rating System of Texas (FIRST) district report and to approve submission to TEA for an elementary class size waiver for the fall semester for one section of kindergarten.

Substitute teachers approved and added to the 2007-2008 list were Mary Henson, Bonnie Rhoades and Melinda Routh. The board entered executive session at 7:20 p.m., returned to open session at 7:56 p.m., and promptly adjourned.

Do You Remember...?-"The Front Porch"

There was a time-not that long ago, when the porch was a much-used part of our lives. The porch had many functions in our daily activities. It was used for social gatherings, relaxing, or working on projects. Great grandma had her spinning wheel there and used it on the porch during good weather. Usually the porch was equipped with cane bottom chairs, a swing and a couple of comfortable chairs for the elders. It was in the swing that young couples did their "courting." Swallows built their mud nests on the ceiling out of the weather.

Each porch had one or more screen doors from the house, most of them were equipped

with a coil spring to keep the screen door closed. As kids, we didn't take time to close the door gently, most of the time we exited on the run allowing the door to slam. The slap of the door seemed to irritate our parents. I cannot count the number of times I have heard, "Junior don't slam the screen door!" I guess all parents then said the same thing, that old screen door is one of the memories of that time.

A person could get close to nature during a thunderstorm, especially at night when the lightening played about, but if there was a blowing rain, we had to go into the house. Also at night, we could sit on the screened porch and watch the "lightening" bugs, and listen to the call of the Whippoorwill, and other night creatures, and to experience the fresh pleasant smell of new-mown hay. Quite often, we caught the "lightening" bugs and put them in jars to watch them light up.

When we lived in tenant houses, there was usually only one porch, we utilized it the best we could. It was there that we ate our watermelons, so as not to mess up the house.

When grandma Sweeney died in 1935, we moved to the "home place." Here we had three porches, one was screened, it was on the northeast, there was another on the southeast and one on the west, we used the one that was most comfortable at the time, each one also had a screen door.

When T.V. came along in the early 50's we turned our T.V. toward the outside in a window and watched it from the porch. This was done because we had no air-conditioning and it was cooler outside.

In recent years there was a song about the porch, I think it said, "I can't believe I'm out here on the porch just a swinging."

My maternal grandfather Curlee was a section-foreman for the Katy railroad. He and his family lived in what was called a section house furnished by the railroad. It had two porches, one was screened and one faced the railroad, which was just a few yards away. We would sit on the porch and watch the trains go by. The engineer would ring the bell and blow the



lonesome steam whistle, and he, the conductor, fireman and brakeman would all wave at us. In those days, there were passenger trains. When they came by all the people riding the train would wave at us. The only passenger trains we have now are the AM Tracks ones. Maybe they should be called "off track" because they derail so much. Speaking of the Katy Railroad, I have had several relatives that worked for them, a grandfather, three uncles, a brother-in-law, a nephew and a great nephew who is currently an engineer. I always wondered why they call the guy that drives the trains an engineer.

In those days, the trains got instructions for telegraphers, and from the depot agent handing the conductor a message on a wire with a handle. There was a telegraph station just south of Hillsboro near grandpa's section house, There were a couple of men I remember who worked there in the 1930s. They were a Mr. Nowlin and Mr. Sly, along with my uncle Robert D. Curlee. Mannie Turner on the mountain had a large house with big porches all around. We



often met there on Sunday afternoon, caught up on family gossip and planned the week's work. The afternoon was not complete unless Otis England played his fiddle.

Now with the fast pace we live in with ringing cell phones, automobiles running around like sugar ants, TV and other noises, it makes one long for the nostalgia of an old fashioned porch to sit, relax and slow down and enjoy a few of the simple pleasures. I have heard recently that some people are including porches in their house plans again.
