MINUTES

A. INTRODUCTORY BUSINESS

- 1. The meeting was called to order at 7:29 p.m. by Chairman Everett Grant. He noted that Director Ronald Kennedy is away and unable to attend tonight's meeting.
- 2. RE: APPROVAL OF MINUTES OF FEBRUARY 28, 2018 REGULAR MEETING ACTION: Motion by Mark Wright, second by Debra Murphy, and voted (684-yes, 120-abstentions) to approve the minutes of the February 28, 2018 meeting as presented. (Hartford and Pineo abstained as they were absent from that meeting.)
- 3. RE: REPORT—SUPERINTENDENT OF SCHOOLS (Including Legislative Updates) INFORMATION: Supt. Ramsay reported on the following:
 - Next Wednesday will be our third Budget Workshop. We will be reviewing the revenue side of the budget. He is hoping to have board approval on April 25th, followed by our district meeting on May 22nd and validation on June 12th.
 - We have been evaluating and reviewing our security processes. An outside safety consultant that we recently contracted with has been in-district visiting our schools, looking at things. Administrators met with him a couple of weeks ago and we will be continuing our conversations on this. We have bids from two companies for security cameras and will be bringing it to the board for consideration soon.
 - The state continues to urge regional cooperation for some type of regional project. He has met with a couple of superintendents. A meeting with Deb Lajoie, of the DOE, on possible funding for an outside facility in-district has been scheduled. This could be something like a voc ed annex in a building outside the high school where we could offer two or three programs. This could lead to an expansion of our voce d programming eventually.
 - There are 9 weeks of school left after this week. June 15th is the last student day if no more snow days.
 - Last Wednesday, there was an incident at the high school that everyone has heard about by now. The incident turned into a perceived threat, but he and Mrs. Willey never felt that students were in danger. Looking back now, he realizes students and parents might not have realized that. There were some communication issues and social media allowed word to spread in a very short

time. Many parents came to pick up their kids. Law enforcement was on site very early in the process and determined there was no credible threat. We have learned from the experience and have already made some changes. Contrary to rumors, plans for such an incident were already in place for a lockdown. The plan was not initiated because they felt there was no reason for a lockdown. We were not prepared for the backlash from social media spreading things so rapidly and not very accurately. We will continue working on our processes and our communication to improve.

• Alfred Moore, Sr., will be retiring from the district after 52 years of service. He was the only remaining employee since the district was formed, and has served as a teacher, bus driver, and part-time transportation director. We wish him well in his retirement and thank him for his service to the district.

5. RE: REVIEW OF FINANCIAL STATEMENTS

INFORMATION: Supt. Ramsay noted that we have 44% of the budget left as of the end of February, and 33% of the fiscal year left. We are in good shape but playing catch-up with trying to have \$500,000 for a balance forward remaining. We are not in a freeze but are watching expenditures closely from now until the end of the year, remembering that we need an estimated \$500,000 for summer salaries, in addition to balance forward monies.

6. RE: ADMIN REPORTS INCLUDING ESSA, G/T, AND PROFESSIONAL DEV.

INFORMATION: Denise Vose—155 students are receiving special education services and 23 are receiving 504 services.

Susan Meserve—Harrington has 159 students enrolled. Registrations for preK and K for next year were held on Friday, with 10 enrolling for PreK and 17 for K. Schools have been working on MEA testing, as required by the state.

Lorna Greene—DW Merritt has 105 students enrolled, and recently registered 11 for preK and 16 for K for next year. Staff participated in Drug Awareness Workshops on March 15 and 16. She attended an ESSA workshop to learn about new reporting requirements and legislative updates. G/T identification process is beginning for the 18-19 school year.

Maria White—Milbridge has 122 students enrolled, with 6 new preK and 20 K registered for next year. Numeracy for ME continues to help ramp up the Math program.

Lucille Willey—Narraguagus has 278 students enrolled. Students have been busy with a Fishermen's Forum for the Skippers' Program, Skills USA Competition for HCTC students, a Peewee Tournament hosted at the high school, Harlem Superstars, National Honor Society and Academic Awards Night, State Math Meeting, and the wrap up of winter sports, as well as many other activities.

ACTION: Maria Frankland, Guidance Director at NHS, reviewed the changes made from 2017-18 course offerings to 18-19 course offerings. Superintendent Ramsay commended the high school for the increase in vocational offerings to students.

Motion by Mark Wright, second by Gary Magby, and voted (unanimously) to approve the NHS Program of Studies for 2018-19 as presented.

2. RE: APPROVAL OF SENIOR CLASS TRIP TO SIX FLAGS & BOSTON

ACTION: Christina Willey, Senior Class Advisor, and River Fenton and Madison Leighton, Senior Class Officers, presented the itinerary for their proposed class trip from May 17-19 to go to Six Flags and Boston, and asked for Board approval to allow them to go. They noted that 39 of the 43 seniors plan to go on the trip along with 6 chaperones. They will visit Quincy Market, the New England Aquarium, and the I-Max Theatre, possible take a Duck Boat Tour, go to Six Flags, and so some shopping on the way home in Portland.

- Give all support staff a \$1.00 per hour increase (increase steps by \$1.00 per step and place on appropriate step;
- Increase Dawn Fickett's salary by 2.5% as other administrators and then add \$3,000 to it.
