Superintendent Tim Myers met with a committee of teachers to talk about a survey for staff and the community to complete regarding the Building Project and Bond Levy. Mr. Myers asked teachers for recommendations of any community members he should contact for input. Meetings were held Thursday, June 5 and Wednesday, June 11, and 12-14 people attended. Mr. Myers created the survey and put it on the Van Buren School web site. He is trying to get the word out to as many people as possible to have them fill out the survey. They are on the information 'input' stage and trying to gather positive and negative comments. Some of the biggest concerns heard so far were from large land owners and included the 37 year payback and the amount of the Bond Issue. Mr. Myers is compiling all the data to present at a future special Board meeting.
