

Rose Bud School Board Meeting  
March 26, 2018

The Rose Bud School Board held its' regularly scheduled monthly meeting on Monday, March 26, 2018. Members present: Wade Weatherley, Steve Bradley, Luke Calhoun, Cody Wortham, and Shawn Gorham.

1. The meeting was called to order at 6:00 p.m. by Wade Weatherley.
