- Rose Bud Elementary staff will implement an Intensive Reading Plan (IRI) for students who possess a substantial deficiency in reading in grade Kindergarten thru Second grade. A substantial deficit in reading for kindergarten students will be determined if a student is delayed in reading skills on the ISTATON assessment. Students who score below 20th percentile will be determined to have a substantial deficiency in reading.
- Communication from the elementary school to parents will automatically go to parents of preschool students in an effort to inform all parents of activities. Elementary principal, Melissa Kirkpatrick will be responsible for making sure that the parents of preschool children receive the same communication as the parents of elementary students concerning school activities.
