Our committee has approved the use of Parent and Family Engagement funds to provide a meal for students and parents who come to the meeting to fill out the FAFSA. Ms. Strain will be available to help students fill out the You Universal Scholarship application to sign up for State Aid to attend college or vocational programs in Arkansas. The members of this group help our school in many ways. They provide many things to parents and students at various times throughout the year. They have helped supply free school supplies during our Annual Open House and throughout the year. During Open House, they provide our students with free haircuts and physical exams as well as food and household items. They also help our school with the Backpack for Kids program which provides a backpack filled with food for needy children to take home on Fridays.
- The Rose Bud High School will conduct annual training for volunteers assisting in instructional programs for parents. This training will be held in the Fall of each year. - The State Board of Education's Standards for Accreditation of Arkansas Public Schools and School Districts requires teachers to participate in Professional Development in the following areas on a rotational basis: (2013-14 and every fourth year after that) 2 hours of Professional Development related to child maltreatment; (2014-15 and every fourth year after that) 2 hours of professional development designed to enhance the understand of effective parental involvement strategies; (2015-16 and every fourth year after that) 2 hours of PD designed to enhance their understanding of teen suicide awareness and prevention; (2016-17 and every fourth year after that) 2 hours of PD in Arkansas History for teachers who provide instruction in Arkansas History. - In addition to the state mandated Parent Involvement Training, our teachers have many other opportunities to learn about how to work with parents as equal partners. Our school district always provides at least two hours of parent involvement training each year in August to our teachers and staff. They use such resources as guest speakers, our parent facilitators, and the IDEAS website through AETN. Wilbur D. Mills Educational Service Cooperative also provides many workshops throughout the year on these topics.

There are other services that other staff members and community members volunteer to coordinate. Families Inc. based in Searcy, Arkansas provides free counseling to our students on our campus on an as needed basis. The I Heart Rose Bud Organization provides many services to our students and families, such as free school supplies at the beginning of the year, free haircuts at the beginning of the year, free physical exams for our students, food items, house hold items, and some clothing items. Our Parent Resource Center has a lot of free information about how parents can help their children learn; it also has free information from colleges and vocational schools in Arkansas for students and parents; it also has information on our local food pantry and clothes closet sponsored by local churches. Our committee provides many free parent seminars on an as needed basis to students and parents. This year, we are offering two financial aid seminars in the Fall; one will give information about federal, state, and local aid and scholarships. One financial aid workshop will have financial aid officers form ASU Beebe as well as Ms. Strain available to help fill out the FAFSA and the You Universal Scholarship. Mrs. Reedy, our FACS teacher, is coordinating a free Stewards of Children Seminar this year for parents and families.
