- I. Requests for public hearing: There was none.
- J. School Report Card Presentation by Building Administration:

Mrs. Ryba and Mr. Hulet presented student achievement reports to the board. The elementary classes' PARCC scores were in line or above state averages for both math and language arts, while the Junior High scores were below state averages for both. Mr. Hulet explained to the board that there would be a renewed emphasis on encouraging students to try their best on PARCC exams. Last year there were many reports of students reporting that they were tired of taking standardized tests and that they did not give their best effort due to the many testing demands the state places on the students.

Dr. Asplund followed up that report with a separate achievement report that showed that student achievement had risen over the past three years. The district gives grade 3-11 students MAP (Measurement of Academic Progress) tests three times per year (Fall, Winter, Spring to measure growth in language arts and math). MAP tests are aligned to the Common Core State Standards, as are PARCC exams. According to last spring's MAP results, district students were scoring significantly higher on proficiency scores, as compared to PARCC. Dr. Asplund stressed that it is very difficult to draw any meaningful conclusions as to why there is such a large discrepancy between PARCC and MAP scores, as last spring was the first time PARCC had ever been given. He then went on to explain that PARCC exams will be different from last year, so it will once again be difficult to draw any conclusions from the results. The district puts much more emphasis on MAP tests as an accurate measurement of student achievement.
