**NOTE:** The federal McKinney-Vento Act requires that homeless children be provided a free, appropriate public school education. It states that residency requirements may not be used to deny such an education to homeless children and youth. Any person who enrolls or attempts to enroll a child in a school other than the school of origin who he/she knows is not a homeless student or provides false information regarding the homelessness of a child or family for the purpose of enabling that child to attend a school other than the school of origin shall be guilty of a Class C misdemeanor.
