1. The Board may conduct a private consultation with its attorney. *Gov't Code 551.071*

REAL PROPERTY

2. The Board may conduct a closed meeting to deliberate the purchase, exchange, lease, or value of real property. *Gov't Code 551.072*

PROSPECTIVE GIFT

3. The Board may conduct a closed meeting to deliberate a negotiated contract for a prospective gift or donation. *Gov't Code 551.073*

**PERSONNEL
MATTERS**

4. The Board is not required to conduct an open meeting to deliberate the appointment, employment, evaluation, reassignment, duties, discipline, or dismissal of a public officer or employee or to hear a complaint or charge against an officer or employee. *Gov't Code 551.074*

**STUDENT
DISCIPLINE**

5. The Board is not required to conduct an open meeting to deliberate in a case involving discipline of a public school child. *Gov't Code 551.082*

**EMPLOYEE-
EMPLOYEE
COMPLAINTS**

6. The Board is not required to conduct an open meeting to deliberate in a case in which a complaint or charge is brought against a District employee by another employee and the complaint or charge directly results in the need for a hearing. *Gov't Code 551.082*

SECURITY DEVICES

7. The Board is not required to conduct an open meeting to deliberate the deployment, or specific occasions for implementation, of security personnel or devices. *Gov't Code 551.076*


**ASSESSMENT
INSTRUMENTS**

8. The Board shall conduct a closed meeting to discuss or adopt individual assessment instruments or assessment instrument items. *Education Code 39.030(a)*

Should any final action, final decision, or final vote be required in the opinion of the School Board with regard to any matter considered in such closed or executive meeting or session, then the final action, final decision, or final vote shall be either:

- (a) in the open meeting covered by the Notice upon the reconvening of the public meeting; or
- (b) at a subsequent public meeting of the School Board upon notice thereof; as the School Board shall determine.
